that on a previous occasion (February 2nd, 1921) it passed a resolution under somewhat similar circumstances, and the Committee reports that in its opinion it is undesirable that a Statutory Body such as the General Nursing Council should be officially represented at a meeting of Associations

which have no such position. That the Scheme of Election amended in accordance with the Resolution of Council has been approved by the Minister. (Circulated.)

In this connection MISS MUSSON asked leave to state that the Scheme circulated was a rough proof and not quite the same as the final draft, and enumerated various amendments.

MISS VILLIERS inquired whether the Scheme for the Election of the Direct Representatives of the Nurses on the General Nursing Council for England and Wales had been laid on the Table of the House, and the CHAIRMAN OF COUNCIL replied in the negative, but said that this would be done.

PRELIMINARY STATE EXAMINATION.

The Committee reported that the third Preliminary State Examination was held on Tuesday, January 13th, 1925, written paper, and on January 20th to 23rd, Oral and Practical part.

1,340 candidates entered.

1,269 sat for the Examination.

71 failed to attend owing to various causes.

Results :--- Passed, 1,043 ; Failed, 226.

It was also reported that Miss Millicent Ashdown, S.R.N., has acted as Assistant Examiner to help in marking the written papers at the January Examination, in place of Miss D. L. Holland, S.R.N.

The Committee further reported that a communication had been received from the Chairman of the Board of Examiners regarding the scale of payment to Examiners on the Board of Examiners. It recommended :-

"That Recommendation 12 of October 19th, 1923, be re-scinded so far as referring to Preliminary State Examination, Section 2, Marking Scripts, and that in this Section all words be deleted after 'A fee of  $f_{6}$  per hundred.'"
