INJURY TO MORAL STATUS

To the Editor of The British Journal of Nursing.

DEAR MADAM,—I shall be obliged if you will publish the following correspondence which has taken place between myself, and the Registrar of the General Nursing Council for England and Wales, omitting the identity of the person

Now that highly qualified professional women are being circularised to pay the Retention Fee, so that their names may be retained upon the Register of Nurses, I am of opinion that we have the right to claim that our names shall not be placed upon a Register which includes a person guilty of theft.

As the General Nursing Council treated a former communication of mine with grave discourtesy, agreeing that it should "lie upon the table," thus declining even the courtesy of acknowledgement, I must decline to have further correspondence with that body, but I make this letter public in the hope that Registered Nurses of high moral standing will request the General Nursing Council to explain why they have retained the name of this criminal on the Register, and what they intend to do to remove it.

Our College of Nurses proposes a scheme of legal protection: would it be possible for our Council to deal with the G.N.C. in our interests in this matter? Surely such an injury to the moral status of Registered Nurses must not be permitted without protest.

DEATH BY MISADVENTURE.

To the Editor of The British Journal of Nursing.

DEAR MADAM, -I was very glad to read your comment on the sad case of the wrong administration of a drug to a patient, and quite agree with you that in the administration of dangerous drugs more than one person should check them before use, and the same applies to the counting of sponges and instruments. For the protection of the patient, and, in the latter case, for the protection of the surgeon, and the member of the nursing staff concerned also, this is most important as a routine practice. An error made in such a case may mean the death of a patient, and as you say, even with care powers of observation may be in abeyance when the human mechanism is over-strained, and moreover when a nurse is working at top speed.

I know that in some hospitals the rule of checking by a second person is observed, but not in all by any means.
