## THE PASSING BELL.

Dr. Waldo, the Southwark Coroner, held an inquest recently on the body of Edith Beatrice Rivette, 54, a certified nurse, of Bromley, Kent, who died in Guy's Hospital from blood-poisoning contracted while nursing a patient. It was stated that early in January she went to Brockenhurst to nurse a little girl suffering from a septic throat. In applying hot fomentations the nurse burned her left wrist. A doctor told her she had poisoned the blister and must be very careful. Miss Rivette insisted on going on with her work, because her little patient was so ill, and she eventually brought the child to Barnes, where she became unconscious after fainting. She was removed to Guy's Hospital, where she died. In recording a verdict of "Accidental death,' the Coroner said that he wished to sympathise with Miss Rivette's relatives. He regretted the less of a ways with was doing such relatives. He regretted the loss of a nurse who was doing such a great work in the world. He did not think the public realised what risks were run by doctors and nurses.

We regret to learn that the body of Miss Mary Jane Elliot, a Queen's Nurse belonging to the Gloucester District Nursing Association, who has been missing, has now been found on the foreshore of the Severn.

Also of the death of Miss Laura Dagmar Smith, whose body was found in the Ribble at Preston. Miss Smith was a member of the Nursing Staff of H.M.S. Britannic which was torpedoed during the war, and subsequently had a nervous breakdown.
