### Disciplinary and Penal Cases.

The Disciplinary and Penal Cases Committee reported that they had considered a case reported by the Registrar in which registration appears to have been obtained by personation, supported by falsified documents.

The case was considered in camera at the conclusion of the meeting, and the following resolution was subsequently sent to the press :-

That a prima facie case is made out, and that the case of Daisy Stewart, S.R.N. 14513, be heard at the next meeting of Council, and that the Registrar be instructed to inform her of the Council's intention, in the manner prescribed by the Rule 17 (6).

### Examination in Mental Nursing.

The Mental Nursing Committee reported that E. Barton White, Esq., M.R.C.S., L.R.C.P., Bristol Mental Hospital, Fishponds, had agreed to serve on the Board of Examiners for Mental Nurses, in place of the late E. S. Simpson, Esq., M.C., M.D., East Riding Mental Hospital, Beverley.

The appointment was approved.

### Correspondence, Interviews and Permits.

The General Purposes Committee reported that the correspondence dealt with in the office between May 1st and the 31st amounted to 2,576 letters received and 3,674 etters despatched; that the interviews numbered 121, and hat 142 Permits were issued for the State Uniform.

#### The State Uniform.

The Council offered no objection to an application from the General Nursing Council for Scotland to be permitted to adopt the Registered Nurses' Overalls and the Cap approved by the General Nursing Council for England and Wales, provided the distinctive button and distinctive badge of the Scottish Council be used.

The public business then concluded and the press withdrew.

# POINTS TO NOTE AND REMEMBER.

### THE NOVEMBER ELECTION OF THE G.N.C.

Every Registered Nurse should note that the election of the 16 elected members of the General Nursing Council for England and Wales takes place in November next, and it is quite time that she considered whom she wishes to represent her and her interests for the next five years, whether she is entitled to vote for the II Direct Representatives of the Nurses on the General Part of the Register, or for the Representative of the Nurses on one of the Supplementary Registers.

It should be remembered that in accordance with the Scheme for the forthcoming Election provided that a Nurse is nominated in accordance with the Scheme laid down, any Registered Nurse may stand for election, whatever her position in the nursing world.

This privilege was granted as a result of the recommendation of the "Select Committee of the House of Commons on the General Nursing Council," appointed on the Petition of the Registered Nurses Parliamentary Council, which took evidence on this point in July, 1925. A PRIMA FACIE CASE.

It is interesting to note in connection with the prima facie case made out against a Registered Nurse in which registration appears to have been obtained by personation, supported by falsified documents," that the proposal of Mrs. Bedford Fenwick when she was a member of the General Nursing Council that a Rule should be drafted dealing with personation was considered unnecessary. As this recommendation was not approved, it will be interesting to know under what charge this case of presumed personation will be presented, as this will be a leading case. Is it a felony, a misdemeanour, or misconduct?
