of Surgeons, who warmly supported the appeal, said that if it was successful he could not conceive of there being a better surgical unit in the country than that provided at St. Bartholomew's. He would place St. Bartholomew's first in all the schools of medicine that had ever existed in the world. It not only trained men to be efficient in their own professional service rendered to the community, but it had set a standard of honour and conduct among medical men higher and nobler than any other medical school in the history of the world.

At noon on Tuesday, April 26th, the Archbishop of Canterbury will open the Students' War Memorial at St. Thomas's Hospital. The memorial is a residential club and hostel, and has cost £60,000.

Damages for Personal Injuries.

Miss Evelyne Magdalene Carter, a nurse, of Halesworth Road, Lewisham, has, by consent, obtained judgment in the Sheriff of London's Court for £1,600 damages and costs in respect of personal injuries due to the falling of a trolley ladder belonging to the South Metropolitan Gas Company, in High Street, Lewisham.

Not a Registered Nurse.

The following announcement appeared in the Evening Standard on February 17th, under the heading "Prison for a Nurse":

At the Hendon Police Court to-day Eugenie Willcock (29), a nurse at the Collindale Hospital of the Metropolitan Asylums Board, was charged with stealing from bedrooms in the hospital sums of £8 ros. and 15s., and £2 from the sisters' room during the New Year dance.

Detective-sergeant Burgess stated that Willcock admitted the theft after first stating that the money was sent to her by her mother. Three ward nurses gave evidence that they missed the money from handbags left in their bedrooms. In one case the money had been left in a locked wardrobe, the key of which was hidden under books in a drawer.

Dr. Paterson, medical superintendent, said that on the night of the theft Willcock was acting as night sister. was how the opportunity to enter the sister's room arose.

Detective Burgess said there had been a great amount of trouble at the hospital during the last five or six months, and a series of losses occurred, each time while Willcock was on duty. The total losses of the night of the charge amounted to £28 15s.

Willcock was sentenced to three months' hard labour. The name of Eugenie Willcock does not appear in the State Register.
