(Medical Superintendent of the Infectious Diseases Hospital), Miss F. E. Pollard (Matron of the I.D. Hospital), Miss H. L. Schlegel (Matron of the Royal East Sussex Hospital).

The point at issue was, briefly, whether or not an average of 15 occupied beds provided a sufficient variety of experience to warrant the recognition of the hospital as a complete

training school in the nursing of infectious diseases.

The representatives of the Hastings Town Council were of opinion that they were, the Chairman and representatives of the General Nursing Council were of opinion that they were not. At the same time the Council was willing to recognise the training in affiliation with that of another hospital.

The Matron expressed the opinion that the difficulty of obtaining probationers would be accentuated if the hospital were not recognised, and said that two probationers were waiting to know the result of the Appeal before deciding whether they would stay or not.

At the conclusion of the evidence Mr. Brock stated that a Report would be made to the Minister, and promised to do his best to get a decision at an early date.

## POOR LAW MATRONS AS EXAMINERS.

At the last meeting of the Marylebone Board of Guardians, as reported in The Marylebone Mercury :-

Arising out of a reference from the last meeting of the Board, the Matron of the Hospital reported that during the past twelve months leave of absence had been granted to her to serve as an Examiner at the Examination of the General Nursing Council on three occasions for four days each, and that a fee was paid.

Mr. Dean said it was stated that the work at the Hospital was so great that it was necessary to add a number of Nurses, and yet the Matron got away twelve days in the year. There must be other Matrons who could do this work, and her wages should be deducted or the fee pooled.

Miss M. E. Broadbent said they certainly thought it an honour to the Institution that the Matron should have been selected for this work, and she pointed out that she was not off for a full day.

The matter was referred back for further consideration.
