The Out-patient Department of the Royal Westminster Ophthalmic Hospital, of which the Duke of Connaught is President, which has been removed from King William Street, Strand, to Broad Street, W.C., is now being carried on in the new hospital, which will be able to deal with 100,000 patients—both in-patients and out-patients— annually. It is hoped that the formal opening may be performed by a member of the Royal Family in June or July.

The Hospital Saving Association distributed no less a sum than £28,370 to co-operating hospitals for the year ending December 31st, an increase of over £6,000 in the corresponding period of the previous year. With the steady increase in membership, which is now over 400,000, it is anticipated that a substantial surplus will be available for the final distribution to the co-operating hospitals at the end of July next.

The King of Afghanistan, who recovered from the effects of his operation for tonsilitis in Berlin, has endowed his room in the nursing home for the free use of patients approved by the directors and the Afghan Legation for the period of ten years, and has made gifts of money to each member of the staff.

The Doncaster Infirmary Committee has accepted a tender for £100,000 for the building of the new infirmary of 120 beds, to be known as the Queen Alexandra memorial wards.

• A report presented at a meeting of the Royal Lancaster Infirmary indicated that 3,700 workpeople of the town had raised £5,000 for the institution by weekly contributions. It was decided to launch an extension scheme to cost £75,000.

The Edinburgh Corporation Bill for compulsory treatment of venereal disease was rejected on Second Reading in the House of Commons by 93 votes to 63. There was a great deal of sentiment expressed during the debate. Sooner or later all diseases by which one human being infects others, even in a less hideous degree than with venereal disease, will be notifiable and compulsorily treated. In the meantime medical science and nursing must protect the public as best they can.

In the Chadwick Public Lecture to be given at the House of the British Medical Association on *J*Tuesday, May 15th, at 8.15 p.m., Major Walter Elliot, M.P., M.B., Ch.B., D.Sc., will give a short review of some recent research work and discuss the experience of certain local authorities. Special reference will be made to Scottish experience, as this comes under the notice of the Lecturer as Under-Secretary for the Board of Health, Agriculture and Educa-tion in Scotland.
