#### DOMINION INTEREST IN THE BRITISH COLLEGE OF NURSES.

At the twenty-seventh annual meeting of the South Australian branch of the Royal British Nurses' Association, held at the Nurses' Home, Kent Town, Adelaide, Dr. H. H. E. Russell, who presided, said he was pleased to state that the British College of Nurses had been established, and he urged all members of the Association. to join it. The qualification for membership provided that they must be faithful to their duty, and loyal to the medical practitioner, and regard as sacred any matters concerning the patient or the medical man. They must be true to the college, and conduct themselves so as to reflect credit upon the institution. He was pleased to note that already 55 South Australian nurses had been admitted to membership.

The Annual Report presented to the meeting also announced that the number of applications for Fellowship and Membership of the British College of Nurses had been 55-37 Fellows and 18 Members. THE BRITISH JOURNAL OF NURSING, which was the organ of the R.B.N.A. and the College, was received regularly by the members, and the Diploma of the College for each accepted applicant had been recently forwarded to them. looking forward to the time when post-graduates from South Australia would take advantage of the privileges of the College, as some of the nurses of Canada were now doing.

This is very satisfactory, and the value of the inter-change of experience and the friendships thus established between the Nursing Profession in the Mother Country and the Dominions can scarcely be overestimated. The links thus forged unite not only the nurses themselves, but the communities which they serve, among whom their influence is far reaching.
