The meeting then terminated.

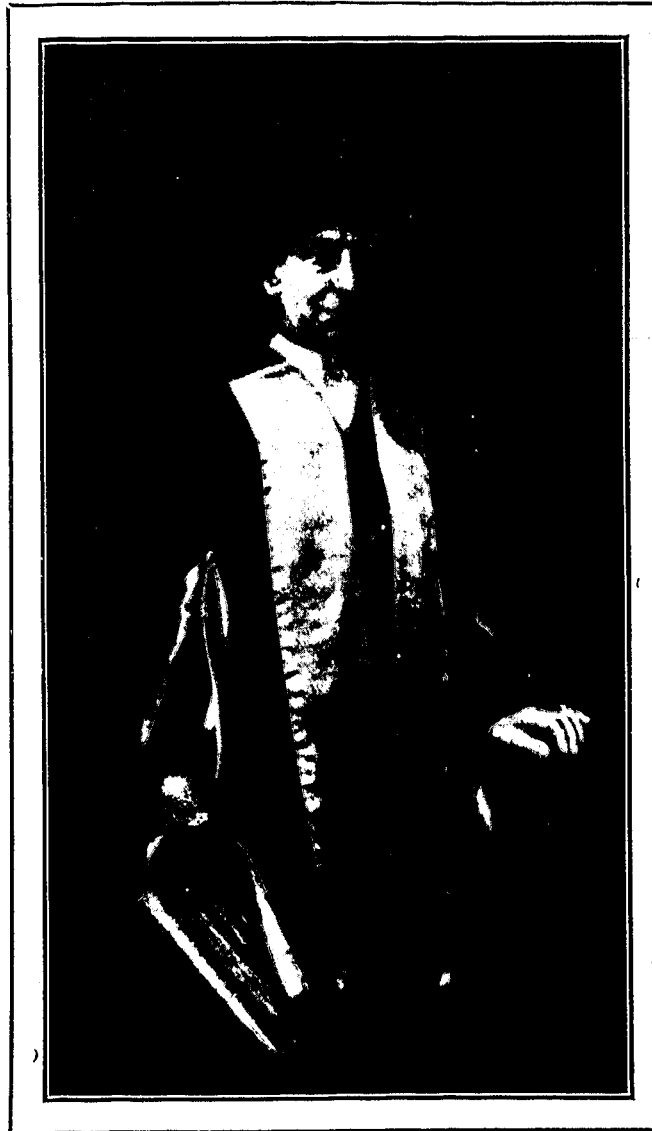
FIXTURES FOR FEBRUARY.
