The President reminded the Council that the College possessed extremely valuable and interesting documents in connection with the State Registration Movement and the International Nursing Movement.

The President proposed and it was agreed that representatives of the College should if possible pay a visit to Quebec and lay laurel wreaths on the tomb of General Wolfe on the Heights of Abraham, and on the tomb of the Marquis de Montcalm in the Ursuline Chapel, Quebec, both of which heroes were mortally wounded and perished at the battle of Quebec, when Canada passed from French to English control. (Miss I. M. G. Davy, F.B.C.N., has since the meeting undertaken this office.)

The Meeting then terminated.
