# **GUY'S HOSPITAL NURSES' LEAGUE.**

The Twenty-Ninth Annual Meeting and the Twenty-First Annual Dinner of the Guy's Hospital Nurses' League was held in the Nurses' Home, Guy's Hospital, S.E., on May roth.

So many members had accepted the invitation to be present at the Dinner that the large Recreation Room was used as a dining room as well as the Nurses' Dining Hall. The meeting was held in the gymnasium of the Massage Department.

The entries for Exhibitions of Needlework, Photographs and Paintings were more numerous this year. Mrs. Burgwin, O.B.E., who again judged the needlework, was very pleased indeed with the excellence of the work sent in, and greatly praised the originality and ingenuity of the exhibitors.

Mrs. Hughes, who judged the paintings and sketches, considered the efforts of the members very praiseworthy.

The prints sent in for the photographic section were interesting and more numerous.

# GENERAL NURSING COUNCIL FOR ENGLAND AND WALES.

The one hundred and second meeting of the General Nursing Council for England and Wales was held on Friday, May 24th, at 20, Portland Place, London, W.I, at 2.30 p.m. Miss E. M. Musson, C.B.E., R.R.C., was in the chair.

# The State Register.

The Chairman announced that the State Register of Nurses for 1929 was now published, and that copies were in the room. The total number of names included being 55,474, made up as follow. General part of the Register, 44,869. Supplementary parts.—Male Nurses, 194; Mental Nurses, 5,962; Nurses for Mental Defectives, 306; Sick Children's Nurses, 1,267; and Fever Nurses, 2,876. The total number registered since the formation of the Registerwas 65,421.

# Absence of Chairman and Vice-Chairman.

The Chairman announced that both she and Miss Cox-Davies, Vice-Chairman, would be absent from England from June 21st as they were attending the meeting of the International Council of Nurses in Montreal. It was agreed to invite Miss Sparshott, who was not present, to act as Chairman, and Miss Hogg as Vice-Chairman until their return.

# The Medico-Psychological Association and the General Nursing Council for England and Wales.

Since March, 1928, correspondence has been taking place between the Royal Medico-Psychological Association and the General Nursing Council for England and Wales upon the demand of that Association that its examination for Mental Nurses should entitle successful candidates to admission of their names to the State Register maintained by the General Nursing Council in the Supplementary Part for Mental Nurses.

The General Nursing Council acceded to the request of the Royal Medico-Psychological Association that a Conference should be held on this matter, and this took place, in camera, on May 23rd. at 20, Portland Place, W.

At the Meeting of the Council on May 24th, Miss Musson announced that the Conference had taken place, and the letter of the Royal Medico-Psychological Association re the Registration of Mental Nurses was now before the Council in its entirety. It had not been possible to prepare the Report of the proceedings at the Conference in time for the meeting of the Council. It was arranged that this should be referred to the Mental Nursing Committee and the whole question brought up on its report at the next meeting of the Council.

"That this Meeting of Members of the Royal British Nurses' Association most strongly deprecates any attempt to interfere with the one portal system of admission to the State Register, such as would result from the adoption of the proposal put forward by the Royal Medico-Psycho-logical Association, that its Examination shall be taken as qualifying for admission to the State Register of Nurses trained in the Nursing of Mental Diseases."
