In forwarding the Resolution, I am to place before you the following arguments in support of it:-

- 1. If adopted, the proposal of the Royal Medico-Psychological Association would create a precedent calculated effectively to destroy the whole system of the one portal entrance to the State Register, a principle which, from the inception of the Registration Movement, has been held to be vital to the efficient working of any Act for the State Registration of Trained Nurses. Any infringement of such system is bound to lead to a lack of uniformity in education, training and examination thus mitigating against the value of the Acts to the community.
- 2. The General Nursing Council, which is responsible for the administration of the Act, should remain unhampered in the exercise of its functions, a condition impossible to maintain if it is subordinated to the necessity of admitting to its Register Nurses examined by a voluntary body over which it has no jurisdiction.
- 3. The Registration Acts have now been established for nearly ten years, and to interfere with their operation in such a way as to induce co-operation with bodies which have no legal recognition is a retrograde step, which should not be tolerated either by Nurses on the General Part of the Register or by those on the Register of Nurses trained in the Nursing of Mental Diseases. To maintain the status of the State Register it must be protected from suspicion of interference or coercion from any other organisation, not analogous to it from a professional point of view, such as would inevitably arise if the demands of the Royal Medico-Psychological Association were acceded to.

namely:

That the one-Portal Examination must be maintained, and that to substitute the Examination of a voluntary Society for that of the Statutory body would be to deprive the Mental Nurses of the privileges enjoyed by all other branches of the profession.

I am instructed to send you this information, and to ask you to be so good as to lay this letter before the Chairman of your Council.

The matter is now referred to our Executive Committee with power to act, and I am to say that we shall desire to give all possible support to the Mental Hospital Matrons, if and when the occasion arises that further action may become necessary.

"That the Council of the British College of Nurses do forthwith communicate to the General Nursing Council for England and Wales its considered opinion that the demand of the Royal Medico-Psychological Association to have its examination for Mental Nurses recognised as a portal of admission to the State Register of Nurses, is one which, if conceded, will inevitably destroy the whole principle of the one portal system of admission to the State Register, a system which is held to be fundamental

to the efficient functioning of the Registration Act.

"The establishment of any precedent, whereby a voluntary body shall be empowered to obtain for itself such a privilege, would tend to dissipate the powers of the General Nursing Council for England and Wales to maintain full control of the Register of which Parliament has appointed it the custodian. Furthermore, if the demand of the Royal Medico-Psychological Association be conceded, other bodies might, on such precedent, make claims that their examinations should qualify for admission to the State Register and in time all uniformity of nursing

educational standards would cease to exist.

"On these grounds Registered Nurses would regard any delegation of power by the General Nursing Council for England Wales in connection with its examinations, as a grave betrayal of the rights of the Nursing Profession secured by Act of Parliament."

## Finance.

The expenditure of fror os. od. on copies of complete Rules and Schedules to the Rules, of the Syllabus of Subjects for Examination (Sick Children's Nurses), Syllabus of Training (Sick Children's Nurses and Fever Nurses) was also sanctioned.

The Chairman of the Council and the Chairman of the Finance Committee were authorised to invest the sum of £2,000 after consultation with the Council's Bankers.
