The Report of the Departmental Committee on the Training and Employment of Midwives was placed before the General Council of the Association at its Quarterly Meeting. As a result of the discussion the following letter, covering a resolution passed by the Council, has been forwarded to the Ministry of Health :-

THE ROYAL BRITISH NURSES' ASSOCIATION. 194, Queen's Gate, London, S.W.7. 30th October, 1929.

The Rt. Hon, the Minister of Health,

Ministry of Health, Whitehall, S.W.1.

SIR,-I am instructed to forward to you copy of a Resolution passed at a Meeting of the General Council of this Corporation yesterday.

My Council consider that the proposals, incorporated in the Report of the Departmental Committee on the Training and Employment of Midwives, to remove from the Central Midwives' Board-

(a) power to approve and inspect training schools and teachers,

(b) power to lay down the training curriculum for midwives, and to formulate its course and length,

and to place these powers with the Ministry of Health is subversive to the progress and development of Midwifery as a Profession. My Council hold that the results of severing such powers from what ought to be the Governing Body of the Profession is calculated to deprive that Profession of self-government, to stultify the powers of the Central Midwives' Board to protect and promote the education of midwives, and likewise its powers to enforce the maintenance of uniform and standardised conditions in the provisions for adequate training in the midwifery schools

In short, the result of the proposals incorporated in the Report, if adopted, would be (as already indicated in paragraph 63 of the Report) to convert the Governing Body of the Profession of Midwifery, which ought to hold full educational and disciplinary power, into a mere penal board with a clerical department for the maintenance of the Roll and powers to appoint an examinations board.

## Resolution.

"That this Council strongly deprecates the tendency of the Report on the Training and Employment of Midwives, to place the profession of Midwifery under the Ministry of Health, thereby depriving the Midwives of self-government,

stultifying their opportunities for professional development and curtailing the functions of the Central Midwives Board for protecting and promoting standards of education for Midwives."
