#### Correspondence, Interviews and Permits.

# Ivy Edna Wiffen, R.M.N.

Mr. D. R. Hawkins wrote from New Scotland Yard, London, S.W.I, on July 16th, 1929, to the Registrar. "Sir,

With reference to your letter of the 11th July (M.S.R./C.B.,) I am directed by the Commissioners of Police of the Metropolis to acquaint you that on the 8th July, 1929, Mrs. Wiffen and her daughter, Ivy Edna Wiffen, were shopping at Messrs. Harrods, Ltd., 101, Brompton Road, S.W., where a sale was in progress. They were seen by a member of the firm's enquiry staff to take various articles from the counters, and were followed stan to take various articles from the counters, and were followed into the street, being subsequently arrested and charged at Walton Street Police Station with stealing and receiving various articles, the property of Messrs.
