A grant of £50 to a Fellow to assist her in taking the Sister Tutors' Course at King's College (University of London). It is satisfactory to report that she has gained the Diploma, passing the examination with credit to herself and to the College, and has now been appointed Sister Tutor, at an excellent salary, to the Woodstock, Mowbray and Victoria Hospitals, under the Cape Hospital Board, Cape Town.

Four grants of ± 35 each were made to enable two Fellows and two Members to take the examination of the Central Midwives Board.

Five grants of $\pounds 4$ 4s. od. each were made to Fellows and Members to enable them to attend the course of lectures in the Nursing of Tropical Diseases, in the Hospital for Tropical Diseases, Endsleigh Gardens. All the candidates were successful in passing the examination which took place at the end of the Course.

The Council has carefully watched events calculated to affect the 'economic security of its Fellows and Members, and taken the necessary steps to safeguard their interest when it appeared likely that this would be affected prejudicially.

The provision made for the legal protection of Fellows and Members under certain defined conditions, is proving very valuable to Fellows and Members, and, as might be expected, when it is made clear that a Fellow or Member has the support of an influential and financially strong body, further steps for her legal protection are usually rendered unnecessary.

No annual dinner was held in London in 1929, but, in its place, the Council of the College combined with other Associations, affiliated in the National Council of Nurses of Great Britain, in giving a Luncheon during the International Congress of Nurses at Montreal, which was declared to be one of the most successful functions during the Congress, and which took place in the Vice-Regal Suite at the Ritz-Carlton Hotel, Montreal, on July 11, 1929. In the inavoidable absence of Mrs. Fenwick, the President of the National Council of Nurses of Great Britain, the guests were also entertained on its behalf by Miss Margaret Breay during the Congress, on various other occasions.
