ELECTION OF FELLOWS AND MEMBERS.

The Applications received were approved and all candidates were elected.

The President expressed satisfaction that applications were received from so many Dominions and other parts of the world, proving that British Nurses appreciated an imperial centre in London.

FINANCIAL REPORT.

The President presented a satisfactory financial statement. Subscriptions to the amount of £292 19s. had been received since the last meeting.

REPORT OF THE EDUCATION COMMITTEE.

Miss M. S. Cochrane, Chairman, presented the Report of the Education Committee held at the College on July 29th, 1930. There were present Miss M. S. Cochrane, Vice-President, in the Chair, Mrs. Bedford Fenwick, President, Miss M. Breay, Vice-President, Miss A. M. Bushby, Miss K. A. Smith, and Miss D. K. Graham.

The agenda included Applications for Grants-(a) Two grants for representatives to attend the dedication of the new wing of the Florence Nightingale School for Nurses at Bagatelle, Bordeaux.

The President explained that, owing to floods, the building had been delayed, and in consequence, the Dedication had to be postponed.

It was agreed that the nomination of representatives of the College invited to be present at the dedication ceremony should be deferred until the date of the event is arranged.

Two applications were considered for the Health Visitors Course of £25 each from: 1. Miss Kathleen Veronica Mahon, F.B.C.N. since July, 1926, trained at the Dewsbury and District General Infirmary. Present post Health Visitor for County Borough of Dewsbury. (2) Miss Margaret Enid Owen, F.B.C.N. since July, 1926. Trained Derbyshire Royal Infirmary, Derby, present post, Health Visitor for Llansantffraid, Montgomeryshire. It was agreed to recommend these applicants to the Council for Grants.

Three applications for Midwifery Grants of £35 each were considered. The applicants were:—

- 1. Miss Lucy L. F. Hornagold, F.B.C.N. since April, 1928. Trained King Edward Memorial Hospital, Ealing, 1924–1927. Present post, Theatre Sister at Grosvenor Hospital for Women. Proposes to train at Queen Mary's Maternity Hospital, Hampstead, starting November 1st.
- 2. Miss Mary McManus, F.B.C.N. since February 1928. Trained Royal Albert Edward Infirmary, Wigan, Lancs. Present post Ward Sister, Graymount Children's Hospital, Belfast. Proposes to train at the Rotunda Hospital, Dublin.
- 3. Miss Edna Mary Ward, F.B.C.N. since May, 1927. Trained Norfolk and Norwich Hospital, Norwich. Present post, taking Housekeeping Course at Moorfield's Hospital, City Road. Proposes to take Maternity Training at Sussex

Maternity Hospital, Brighton, beginning in October. It was agreed that these three ladies were suitable candidates, and should be recommended to the Council for a Grant each of £35 to take Midwifery Training.

Recommendations were submitted concerning a Course of Instruction in Housekeeping and on the Autumn Course of Lectures on Tropical Diseases.

Title of Sister Tutors' Group.

Consideration of the title of Sister Tutors' Group referred from the Council was considered.

Miss D. K. Graham reported that she found there were many trainers of Nurses for the State Examination who were not Sister Tutors. Many were Matrons and Assistant Matrons anxious to attend the Sister Tutors' classes, and not being Sister Tutors felt they could not do so, chiefly because they themselves were of a higher professional rank, and Miss Graham suggested the word "Sister" be omitted and "Teacher" substituted.

After some discussion, Miss Cochrane recommended from the chair that the title "Sister Tutors' Group" be changed and in future termed "Tutorial Group." It was unanimously agreed that the Education Committee recommend that in future the title, "Sister Tutors' Group" be changed to "Tutorial Group."

Miss Graham thought the decision of the meeting would give great satisfaction.

Upon consideration of the agenda of the Annual Meeting of the National Council of Women of Great Britain, to be held at Portsmouth in October, it was agreed that the representative be instructed to vote for all resolutions on the Preliminary Agenda save Nos. 6, 8 and 9; it was agreed that Miss Mabel M. P. Siggers, F.B.C.N., Sister Tutor at St. Mary's Hospital, Portsmouth, be asked if she would attend as a delegate the meetings on October 7th, 8th and 9th of the National Council of Women of Great Britain, to represent the British College of Nurses.
