Standing Advisory Committee on International Affairs.

Miss M. Breay presented a short Report of the work of the Committee which had been actively engaged exploring the question of the proposed International Memorial to Miss Florence Nightingale. Her residence, 10, South Street, Park Lane, W., was still in the market, and it was agreed to make a public appeal for money to finance the memorial.

Copious correspondence with Headquarters at Geneva was reported and replies approved.

Amendments to Constitution.

It was agreed to recommend two amendments sent up by the British College of Nurses for discussion at the Annual Meeting of the Grand Council.

Draft of Annual Report.

The draft Annual Report to be presented at the Annual Meeting of the Grand Council was approved.

Statement of Accounts.

A Statement of Accounts was presented to be audited for presentation to the Annual Meeting. It was agreed that Miss Breay, Hon. Treasurer, should make an explicit statement in detail and draw attention to the limited income of the National Council as the *per capita* fees to the amount of over £477 subscribed by the affiliated Associations merely pass through the bank for the use of the International Council of Nurses at Geneva.

Date of Annual Meeting.

The date of the Annual Meeting was agreed. To be held at the rooms of the Medical Society of London, 11, Chandos Street, Cavendish Square, W.1, on Thursday, November 27th. Tea at 4 p.m. Meeting, 4.30 p.m. (It was subsequently found the rooms were not available on the 27th, so have been secured for Friday, November 28th.)

The Meeting then terminated.
