# THE NATIONAL COUNCIL OF NURSES OF GREAT BRITAIN.

#### THE ANNUAL MEETING.

## Minutes.

The Minutes of the last meeting were read and confirmed.

#### Correspondence.

A letter of sympathy from Mlle. L. Chaptal, President of the International Council of Nurses, and of the National Association of Trained Nurses of France, expressing deep sympathy in the national catastrophe of the loss of Rioi.

A letter from Miss R. E. Darbyshire, President of the University College Hospital Nurses' League, expressing

pleasure at its affiliation with the Council.

A letter from Miss E. Plumley, Hon. Secretary of the Mariabelle Fry and Evelyn M. Eden Benevolent Funds, asking the Council to appoint another representative upon the Trust, necessitated by the resignation of Miss Edith Mellor. It was decided to ask Miss S. Vian, Matron of the Royal United Hospital, Bath, to act, or, if she were unable to do so, an alternative nominee.

# The Report of the Executive Committee.

In the absence of the Hon. Secretary, the President presented the Report of the Executive Committee, which stated that since the last Annual Report was issued the work of the Council had steadily progressed. The Executive Committee had met in April and October, and transacted a large amount of business. The Advisory Committee on International Affairs met in February,

May and July.

The Executive Committee reported that it had been much concerned with the possibility of acquiring and establishing as a Florence Nightingale Foundation, the house, No. 10, South Street, Park Lane, London, W., where she lived for so many years, and in which she died. The action taken in this connection—together with the correspondence relating thereto, especially with Miss M. A. Nutting (New York, U.S.A.) and Miss Nightingale's relatives—is set out at length in the Report, which will be circulated to the Affiliated Associations.

It was reported that during the year the Association of Queen's Superintendents, and the University College Hospital Nurses' League, had been affiliated to the Council.

The following change of Presidents had taken place in Affiliated Associations: Miss M. E. Sparshott is now President of the College of Nursing, Miss M. F. Hughes of the Leicester Royal Infirmary Nurses' League, and Miss D. E. Bannon of the L.C.C. School Nurses' Social Union.

Miss B. Moase and Miss E. Jenkins, nominated by the Prince of Wales General Hospital, Tottenham, Nurses'

League, have been appointed its Delegates.

An Interim Congress of the I.C.N.

The Nurses' Association of India, which wished to arrange an Interim Conference of the International Council of Nurses in Calcutta in 1931, have since withdrawn the invitation, and in the opinion of the Secretary of the I.C.N., there is not sufficient support for such a Conference to be held elsewhere.

### In Memoriam.

The Committee reported with deep regret the deaths of Miss A. W. Gill, R.R.C., a former Director of the Council, and Miss A. Carson Rae, who also had held office as a Director, and was a prominent member of several associations affiliated to the National Council of Nurses.

The Report was adopted.

The Council empowered the Executive Committee to deal with questions which might arise in connection with No. 10, South Street, or other matters of urgency, and approved of a letter on the subject being sent to the Press signed by well-known members of the Nursing Profession.
