what she was doing. At the moment she was in a Nursing Home, and the solicitors instructing him had endeavoured to get the General Nursing Council to withdraw the prosecution on that ground, but the Council had not seen fit to do so. It would be impossible for him to dispute that all the things alleged were committed, but defendant, although not in such a state as to be certifiable, was suffering from a mental disease.

No Alternative but to Convict.

The Chairman said the Bench had no alternative but to convict, and the penalty would be $\pounds 3$.

THE PASSING BELL.

We greatly regret to record the death on March 2nd of Miss Annie Warren Gill, C.B.E., R.R.C., Companion of the Order of the British Empire. Miss Gill was trained at the Royal Infirmary, Edinburgh, where she subsequently held the positions of Night Superintendent and Assistant Lady Superintendent. She was appointed Matron of the Edinburgh and East of Scotland Hospital in the South African War, and later Matron of the Concentration Camps in the Orange River Colony, and received the Royal Red Cross for her services in South Africa. She was appointed Matron of the Royal Berkshire Hospital in 1903, and in 1907 succeeded Miss Spencer as Lady Superintendent of Nurses at the Royal Infirmary, Edinburgh.

Miss Gill was a Principal Matron in the Territorial Army Nursing Service (2nd Scottish) and the Assistant Editor of the BRITISH JOURNAL OF NURSING was indebted to her for much BRITISH JOURNAL OF NURSING was indebted to her for much courtesy and kindness in September, 1914, when, hearing she was in Edinburgh, she invited her to be present at the send-off of the first Scottish Unit to the War, and afterwards, at an extremely busy time, took her to the Territorial Hospital at Craigleith. For her services in the Great War Miss Gill was awarded a bar to the Royal Red Cross, and was made a Com-panion of the Order of the British Empire panion of the Order of the British Empire.

Miss Gill took a considerable interest in nursing organization and attended the Interim Conferences of the International Council of Nurses in Paris (1907) and Geneva (1927). After consultation with Mrs. Bedford Fenwick, she founded the Scottish Matrons' Association on the lines of the Matrons' Council of Great Britain and Ireland, and acted as its Chairman for many years. She was appointed a member of the General Nursing Council for Scotland in 1920, and was afterwards an elected member. She was elected President of the College of Nursing in 1927, but resigned through ill-health before the conclusion of her term of office ill-health before the conclusion of her term of office.

Miss Gill died at Hove, and the funeral took place at Malew Church, Isle of Man, on February 7th. A Memorial Service, attended by many of her friends and colleagues, took place in the Chapel of St. Thomas's Hospital, London, on the same day.
