# THE BRITISH COLLEGE OF NURSES.

### REPORT OF THE COUNCIL.

The Fifty-fourth meeting of the Council of the British College of Nurses was held at 39, Portland Place, London, W.I, on Saturday, April 18th, at 2.15 p.m. The President, Mrs. Bedford Fenwick, was in the Chair, and the following members of the Council were present :- Miss M. Breay, and Miss M. S. Cochrane, R.R.C., Vice-Presidents; Miss A. M. Bushby, Miss Norah Farrant, Miss D. K. Graham, Miss I. Macdonald, Miss K. A. Smith, R.R.C., Fellows, and Miss H. G. Ballard, and Miss K. M. Latham, R.R.C., Members.

Prayers having been read by the Secretary, the Minutes of the last meeting were confirmed. A letter was received from Miss Bright, regretting inability to attend the meeting.

Letters acknowledging the Resolution sent from the Council re conditions of training and qualifications for all new entrants to appointments under the Public Health Service, from (a) the Minister of Health, (b) the Secretary, Departmental Committee on Local Government Officers, (c) the Secretary, the National Council of Women of Great Britain.

A letter from the Executive Committee of the Scottish Nurses' Association, signed by the President, Mrs. Strong, and the Secretary, Miss McAra, addressed to the Scottish Members of Parliament, protesting against "The Nursing Profession (Wages and Hours) Bill," introduced by Mr. Fenner Brockway, M.P.

Macaulay, Kent County Mental Hospital, Maidstone, re Administrative Class; from Miss Mary McManus, notifying that she had successfully passed the examination of the Central Midwives Board, congratulations were sent to her from the Council; from Miss D. F. Vidal, re the Sister Tutors' scholarship of £150 offered by the National Association of Local Government Officers; from Miss E. Haslam, reporting successful tour of Lectures to the Women's Institutes; from Mrs. J. Maud Bowie re ownership of the Scottish Nurse, explaining that it is the property of the publishers, M'Naughton & Sinclair, of Glasgow and Edinburgh, and that it is edited by a Registered Nurse, and letters of thanks from Miss E. Riley, Dr. Stanley Wyard, Miss A. T. Hyde, and many letters of thanks for Diplomas, and on public affairs from the Howard League for Penal Reform, asking for support of a Resolution ve facilities for expert examination of offenders (Physical and Psychological) in connection with Juvenile Courts, of which the Council unanimously approved. From the National Council of Women, Harrogate Branch re additional benefit of the services of qualified chiropodists for insured persons. From the Secretary of the National Council of Women of Great Britain, enclosing the Preliminary Resolutions and Programme of the Conference to be held at Aberdeen in June 1931.
