#### MEMBERS OF BOARD OF DIRECTORS OF I.C.N. AT GENEVA.

After letters of regret for absence had been read, Miss Sewart announced that she had received letters of resignation from Miss Lakeman and Miss Erskine.

Miss Sewart then read correspondence which had passed between the Mental Hospital Matrons' Association, the General Nursing Council and the Association of Hospital Matrons regarding the possibility of arranging for probationers from mental hospitals to take a three or six months' course in general nursing in a general hospital during their period of training in order to facilitate their taking the State Examination.

Discussion following the reading of these letters led to the agreement that the Honorary Secretary should write to the Association of Hospital Matrons asking whether the matter was to be brought forward on the agenda of the next meeting, and that, if the reply were in the affirmative, two members of the Mental Hospital Matrons' Association, who were also members of the other Association, should make a point of attending that meeting.

Miss M. S. Rundle, R.R.C., D.N., was, on the nomination of the Executive Committee, elected a Vice-President of the League, and Mrs. Hadfield re-elected Treasurer.

Satisfactory reports were received (I) from the Treasurer who notified a balance in hand of £129 9s. 4d. (2) The Secretary who notified the membership of the League as 1,296, and (3) the Secretary of the Benevolent Fund which, in her unavoidable absence, was presented by the General Secretary.

The Financial Report of the Isla Stewart Memorial Fund showed that dividends received during the year amounted to £44 10s. 3d.

Miss James, Miss McCulloch Smith, Mrs. Dell and Lady Gillies were elected members of the Executive Committee.
