# AN APPALLING CHARGE.

On July 22nd, Annie Robson, an unregistered nurse, was at Leicester County Police Court committed for trial at Leicester Assizes on the appalling charge of murdering Mrs. Kate Mildred Alice Pochin, of Barkby Hall, Leicester-

shire, on July 8th.

Superintendent Hall said that in January of this year Mrs. Pochin underwent an operation for appendicitis, and after her return home in March Nurse Robson was engaged to look after her. In July, Mrs. Pochin had so far recovered that her services could be dispensed with, and the engagement was to terminate on July 9th. On the morning of July 8th warm water was taken to Mrs. Pochin's bedroom by a maid. Shortly afterwards Miss Robson was seen to enter Mrs. Pochin's bedroom with a large enamelled jug containing boiling water. Immediately afterwards screams were heard coming from the bedroom, and Mrs. Pochin rushed out wearing only slippers. She was taken to a room adjoining, and a doctor found that she was severely scalded on the back, chest, head and face, and there was a wound which was bleeding on the left side of her forehead. She was immediately removed to hospital at Leicester and died on Tuesday morning.

At the subsequent inquest, the City Coroner (Mr. Edward Fowler), said it was alleged that Nurse Robson poured boiling water over Mrs. Pochin and hit her on the head with

a water jug.

Miss Robson reserved her defence.
