## THE PASSING BELL.

We regret to record the death on August 15th, at Camberwell House, Peckham, of Miss Louisa Griffith, M.B.E., formerly the greatly respected matron for 30 years of Hackney Hospital, in her 68th year. The funeral took place at Kensal Green Cemetery.

The death on August 9th, at Horton House, Epsom, of Lieut.-Colonel John Robert Lord, C.B.E., M.D., F.R.C.P.E., Medical Superintendent, Horton Mental Hospital (L.C.C.), creates a vacancy on the General Nursing Council for England and Wales amongst the nominees of the Minister of Health.

Lieut.-Colonel Lord was deeply interested in Mental Hygiene, he assisted in the founding of the Congress of the Permanent International Committee for Mental Hygiene, and attended the first International Congress on Mental Hygiene held at Washington in May, 1930. He was the honorary secretary of the National Council for Mental Hygiene, and also edited the *Journal of Mental Science*.

## THE MENTAL HOSPITAL AND INSTITUTIONAL WORKERS' UNION.

The Address of Mr. C. Bartlett, President of the Mental Hospital and Institutional Workers' Union to its Coming-of-Age Conference in London in July, as reported in its official Journal, touches on a diversity of matters affecting the Nursing profession, and Mr. Bartlett's views concerning them.

On the important question of female nursing in male mental wards, a system which Mr. Bartlett says is shortly to be introduced by the London authorities, he remarked that he hoped the delegates would be prepared to resist by all reasonable and constitutional methods "this deplorable and abominable practice."

Mr. Bartlett stated that since their last Annual Conference the name of the Union had been changed and its basis broadened.
