Committee. Miss Elnora Thomson (U.S.A.) was elected a member of the Congress Programme Committee, Miss M. Breay to the Committee on Revision of the Constitution and By-Laws, and Miss Mary Roberts (U.S.A.) to the Committee on Ethical Standards. Report on Standing Committee on Finance. A resolution on a limit on Dues from the American Consideration was given to the Nurses Association. management of the International Nursing Review, the official organ of the I.C.N. It was agreed to reprint in pamphlet form the History of the International Council of Nurses from its inception in London in 1899 to the meeting in Helsingfors in 1925. The President had ordered 100 copies, which order she asked might be endorsed—as it would be advisable that this page of nursing history should be studied in every Training School. The question of a Nurse Field Secretary to work in the Health Section of the Secretariat of the League of Nations under Dr. Rajchman, the Director of the Health Section, was fully discussed, and a sub-committee empowered to arrange details subject to the understanding that the Board of Directors was not willing that such nurse should be described as a Field Secretary of the International Council of Nurses, as she would not in any way be under the control of the Board of Directors, nor could she express the considered opinion of the I.C.N. The relations of the International Hospital Association to the International Council of Nurses were discussed.

The Special Committee of the Florence Nightingale Memorial.

As Chairman of the Florence Nightingale Memorial Committee, Mrs. Bedford Fenwick presented a Report which was adopted. A sub-committee was appointed to consider the subject and presented to the Directors the following recommendations :-

RECOMMENDATIONS OF THE SUB-COMMITTEE.

That the Florence Nightingale Memorial Committee I. be extended by the inclusion of the Presidents of all Member Associations.

2. That the Report of the Memorial Committee submitted by Mrs. Bedford Fenwick be circulated with the invitation to serve.

3. That they be informed that it is suggested that ultimately-when the Committee has formulated some more concrete suggestions—influential persons in each country shall be included in the organising committee.

4. That the members of the Board of Directors assembled in Geneva regret that they cannot recommend the acquisition of 10, South Street, London, Miss Nightingale's house, as it is in a derelict condition, the space available is small, and the cost prohibitive.

5. The Board suggest that the Foundation should be in London, that it should be of an international character, and a living memorial—not a museum. The suggestion which most appeals to the Directors assembled in Geneva is that the memorial should take the form of an endowed foundation for post-graduate nursing education.

The Report was adopted.

The Executive Committee decided to consider the question at the Annual Meeting

The Annual Report.

Miss M. Breay, in the absence of Miss Villiers, read the Draft of the Annual Report to be presented to the Annual Meeting of the Grand Council in November.

Audited Statement of Accounts.

Miss M. Breay, Hon. Treasurer, presented the Audited Statement of Accounts to be presented to the Annual Meeting. She also placed a report of the financial position, of the Council before the Committee-as the source of income is so limited-the per capita fees amounting to many hundreds of pounds a year, merely passing through the office

for transmission to the headquarters of the I.C.N. in Geneva.

The Committee agreed to summon the Finance Committee to consider the matter and report to the Grand Council.

Date of Annual Meeting.

It was agreed, if possible, to hold the Annual Meeting at the Rooms, 11, Chandos Street, Cavendish Square, W., on Friday, November 27th, but as the Rooms were not available on that date, the Annual Meeting will be held on Wednesday, November 25th, at the same address. Tea to be served at 4.30 p.m., meeting 5 p.m. The meeting then terminated.
