Miss Breay explained that the actual balance to the credit of the National Council on September 30th was £5 18s. 3d., and £13 11s. 2d. represented fees which would become due to the Treasurer of the International Council of Nurses on January 1st, 1932. She also reported that since the accounts had been audited she had received £229 from the College of Nursing as its per capita fees-July to December-for the International Council of Nurses.

It was moved by Miss Cox Davies and seconded by Miss

E. S. Innes, and agreed, that the Report be received. The President said she thought the Council could congratulate itself on the amount of work done for the money expended but the immediate question was how to obtain an adequate income for the needs of the National Council when so much passed through its Treasury to the International Council of Nurses.

The immediate question was how could the Council be provided with an adequate income for its important national work, including the exercise of national hospitality ? It would be well to instruct the Finance Committee to explore

She reminded the Council that next year would be the year before the quadrennial meeting of the International Council of Nurses in Paris and Brussels and would entail considerable preparation on the part of the National Council and extra expenditure.

Miss Lloyd-Still then proposed that those present should take back the Resolution to their respective Associations. and seek their help, she was certain that it would be sympathetically received.' This was seconded by Miss.
