At the Meeting of the Parliamentary and Legislation Sectional Committee of the National Council of Women of Great Britain, held at Murray House, on Wednesday, March 18th, Mrs. Bedford Fenwick, President, British College of Nurses, spoke to the Committee upon the Nursing Profession (Wages and Hours) Bill, introduced into the House of Commons by Mr. Fenner Brockway She explained how disastrous the Bill would prove to be to the sick public and to the registered nurses if it ever became Law. Mrs. Fenwick also informed those present that the Bill had been drafted without reference to the Nurses Organisations, the British College of Nurses, the Royal British Nurses' Association and the College of Nursing, that it was being blocked and that the Nursing Profession generally desire to maintain the vocational privilege of nursing the sick humanely.

The Report was adopted.

THE SECRETARY'S STATEMENT.

The Secretary presented an interesting Statement of College activities and expenses, etc. The Nomination Paper for the election of Fellows and Members was passed, and it was agreed that these Forms would be procurable from the Secretary on and from April 15th next.

THE DEPARTMENTAL COMMITTEE ON CONDITIONS OF SERVICE OF LOCAL GOVERNMENT OFFICERS. Resolution.

A Resolution was considered and agreed in the following terms, on the qualifications for new entrants to the Public Health Service:-

"That the Council of the British College of Nurses is of opinion that all new entrants to appointments under the Public Health Service, such as Health Visitors, Superintendents of Maternity and Child Welfare Centres, Tuberculosis Visitors, School Nurses, Municipal Midwives and Infant Life Protection Visitors, should be Nurses with a three years' qualification of training, and who are Registered on the General Part of the State Register of Nurses.

In addition to this basic qualification they should also hold the Certificate of the Central Midwives Board and a certificate recognised by the Ministry of Health for all Health Visitors as laid down in paragraph 8 of the Statutory

Rules and Orders 1930, No. 69.

It was agreed that a copy of the Resolution be sent to the Minister of Health, the Royal Commission on Local Government Officers, the National Council of Nurses of Great Britain, the National Council of Women, and be given other appropriate publicity.

THE NURSING PROFESSION (WAGES AND HOURS) BILL.

It was reported that immediately after the last meeting of the Council, the "Nursing Profession (Wages and Hours) Bill," introduced into the House of Commons by Mr. Fenner Brockway, was printed and down for Second Reading on Thursday, February 26th. Prompt action was taken by the President and available officers of the College, the Royal British Nurses' Association, and the College of Nursing, to block and oppose the Second Reading of the Bill, which had been drafted without the knowledge of the Registered Nurses, and which would be, if it became law, most disastrous to the efficient care of the sick, and to the economic welfare of the Nursing Profession.

The Council decided to continue opposition to the Bill.
