INSPECTION OF CHRISTIAN SCIENCE HOUSES SHOULD BE MADE COMPULSORY.

To the Editor, THE BRITISH JOURNAL OF NURSING, 39, Portland Place, W.I.

DEAR MADAM, -In an article in your April issue, commenting on the death of a young girl, you say she had been suffering for five years from pulmonary tuberculosis. the inquest, the mother stated that the first sign of illhealth, or any suspicion of it, arose on the girl's return from her summer holiday last year when she said she had contracted a chill.

Conclusions drawn from a newspaper account of proceedings are frequently very different to those formed by one who has attended the inquiry and heard the evidence, and should not be accepted without careful inquiry. article, also, I consider, is written under a misapprehension.

Christian Scientists are particularly careful to use and apply the term "Christian Science Houses" to those institutions for which Section 7 of the Nursing Homes Registration Act, 1927, makes special provision, and which were rendered necessary by the extraordinarily wide terms of the Act. These Christian Science Houses are under the supervision and control of a committee of the Church of Christ, Scientist, specially appointed for this purpose, and it is through this committee alone that application for their exemption in terms of the Section is made to the Minister of Health. While it is true that the method of dealing with illness and disease by Christian Scientists is essentially different from that of the medical profession, yet since they both have the same object and purpose, namely, the alleviation of human suffering, it is unfortunate that the article in your paper should have been written from such a critical standpoint.

[We see no evidence in the above communication that our reference to the case alluded to in "Echoes" in our last issue is too critical of the system of treating disease by prayer alone and denying alleviation of medical and nursing science to the patient. We are still firmly convinced that it is injurious to the public interest to have omitted Christian Science Houses, alluded to in the marginal reference of the Registration of Nursing Homes Act as "Christian Science Nursing Homes," from inspection, as provided in the Act for all other Nursing

Homes—conducted by Registered Nurses—where the sick are attended by Registered Medical Practitioners.

If they are not to be inspected, these "Houses" should not

have been granted the status and responsible liberty to admit

the sick, granted to them in the Act.

This is not the first inquest of death in a Christian Science House which has called for criticism in this journal—and until such time as the public are further protected in this connectiondoubtless it will not be the last—the sooner the Act for the Registration of Nursing Homes is amended to give free access for the inspection of Christian Science Houses the better.—ED.]
