Miss Braye was elected a Vice-President, on relinquishing the office of Hon. Treasurer, which she had held for 12 years. The President said that Miss Braye had done valuable work, which was much appreciated by the League and a cheque for £20 would be sent to her as a personal gift from many members, with a suggestion that she might like to use it for attending the International Nursing Conference next year. GENERAL NURSING COUNCIL FOR ENGLAND AND WALES.

The one hundred and thirty-sixth meeting of the General Nursing Council for England and Wales was held at the offices of the Council, 20, Portland Place, London, W.I, on June 24th. The Chairman, Miss E. M. Musson, C.B.E., R.R.C., presided.

Finance.

On the recommendation of the Finance Committee, Bills and Claims submitted for payment were approved, and the sum of £100 for Postage Stamps, £25 for Insurance Stamps, and £5 for Petty Cash were allowed.

Registration.

On the recommendation of the Registration Committee, the Returning Officer has appointed Mr. T. Kennett, Solicitor, Town Clerk's Office, St. Marylebone, as Deputy Returning Officer at a fee of twenty-five guineas, in connection with the forthcoming Election of Council.

It was agreed to grant duplicate Badges to two nurses who had reported the loss of theirs a year ago.

Applications for approval for Registration on June 24th ere : General Register, by Reciprocity, 11; Supplewere mentary Register for Fever Nurses, by Examination, 2, by Reciprocity, 1. Total, 14. It was agreed that 21 nurses who had hitherto failed to

pay their Retention Fee, and now wished their names re-included in the Register, should be reincluded.

Education and Examination.

On the recommendation of the Education and Examination Committee, it was agreed :-

"That the provisional approval as a complete training school for Fever Nurses be granted to each of the following hospitals :

Hendon Isolation Hospital, London, N.W.9, for a period of two years.

Cuddington Isolation Hospital, Banstead, for a period of one year. Plymouth City Isolation Hospital, for a period of

one year.'

"That provisional approval as a complete training school for general nurses be granted to the following hospital, which is at present approved in affiliation with St. James Hospital, Balham, London :-

Battersea General Hospital, London, S.W., for a period of one year.'

"That the following hospital, the provisional approval of which expired on April 24th, 1932, be now approved as a complete training school for Fever Nurses :----

Florence Nightingale Hospital, Bury." "That the following additional schemes of affiliation be approved under Section I (I) (a) of the Council's Scheme of Training :

National Hospital for Paralysis, Queen Square, London, with Bolingbroke Hospital, London.

Liverpool Open-Air Hospital for Children, Leasowe, with Guy's Hospital, London. ; Royal United Hospital Bath; Hertford County Hospital.

Royal National Hospital for Consumption, Ventnor, with Woolwich War Memorial Hospital, London."

That the cancellation of the schemes of affiliation between (r) Brompton Hospital for Consumption, London, and University College, Hospital, London; (2) National Hospital, Queen Square, London, and Royal Berkshire Hospital, Reading, be approved.

The death was reported of Miss E. F. Mayman, S.R.N., Matron, Gravesend and North Kent Hospital, a member of the Panel of Examiners.
