THE COUNCIL MEETING. Educational Grants.

At the last Meeting of the Council of the British College of Nurses, held on Saturday, July 23rd, at 39, Portland Place, London, the allocation of Educational Grants recommended by the Education Committee was approved,

and it was agreed that :-

Two Midwifery Grants of £35 each be awarded for training in Midwifery and Central Midwives Board Examination, to Miss M. C. Hall, M.B.C.N., since September, 1929, Trained, Fulham Hospital, Hammersmith, at present Ward Sister, Fulham Hospital; and to Miss M. J. Paterson, M.B.C.N., since January, 1931, Trained, St. Leonard's Hospital Shoreditch at present Queen's District Navys.

Hospital, Shoreditch, at present Queen's District Nurse.

Two Housekeeping Grants of £10 each towards the expenses of a Hospital Housekeeping Course to:—Miss L. J. Cakebread, M.B.C.N., since January, 1927, Trained Westminster Hospital, London, at present Holiday Sister at Sanatorium, Braintree, Essex, who will take this Course at the University College Hospital, London; and to Miss L. Clark, M.B.C.N., since July, 1930, Trained Nottingham General Hospital and Ilford Isolation Hospital, at present Ward Sister, St. Andrew's Hospital, Devons Road, E.3, who will take Course at King George Hospital, Ilford, Essex.

It was reported that no application for a Health Visitor's

Grant had been received.

Administration Classes.

Arrangements are being made to hold eight Administration Classes, limited to twelve Fellows and Members of the British College of Nurses, in the Autumn and Spring. By the kind consent of the authorities, visits will be made during the Autumn Course to the new Nurses' Home in connection with Charing Cross Hospital; the Tuberculosis Settlement, Papworth Hall, Cambridge; Bethlem Royal Hospital, Monks Orchard, Beckenham, Kent, and the Preliminary Training School and Departments at the London Hospital, Whitechapel, E.1.

It is deeply regretted that we have lost, by death, seven Fellows and one Member during the year.

This year the Council will lose the very valuable services of Miss Kathleen A. Smith, R.R.C., Fellow, and Miss Alice M. Bright, Member. These ladies have served for three years and the former has also served as Chairman on the Social Schemes Committee.

Only two Nomination Papers for Election of Fellows to the Council have been received—for Miss M. S. Cochrane, R.R.C., Vice-President, and Miss A. M.. Bushby. These two ladies were appointed in the first instance by the Trustees, and therefore were now eligible to submit themselves for election by Postal Ballot by their colleagues for a further three years' term of office.
