AGENDA. Minutes.

The Minutes of the last Annual Meeting were read and

The President stated that with regard to the Questionnaire (1) on Nursing Education, (2) on Nursing Practice, Miss Rundle, Secretary of the College of Nursing, was asked if she could help with the replies. This she had kindly done, and it had been sent to Headquarters of the I.C.N. at Geneva.

The President called the attention of the Meeting to a point of order. She informed them that advice had been taken, and the reading of the Minutes of the Special Meeting of the Grand Council could be referred to another Special Meeting, if agreed by the Grand Council. This was agreed.

Correspondence.

Letters received would be considered later with the Reports. The President pointed out that under the present Constitution delegates nominated by associated organisations were elected and had to be approved by the Executive Committee which met once in six months, before being eligible to attend Council Meetings. Therefore if through sickness and retirements Associations had not always their full complement of delegates the Council would have to decide how to remedy this matter.

THE REPORT OF THE EXECUTIVE COMMITTEE.

The President presented the Report of the Executive Committee, which showed that very strenuous work had been successfully accomplished. Five important Leagues of Nurses had been affiliated, The London, Middlesex, Charing Cross, St. Mary's, Paddington, and the Royal Alexandra, Paisley, an additional membership of nearly 1,500. The appointment of new Presidents and Delegates were recorded associated in self-governing Associations, in which self-expression and professional responsibility had full scope.

The successful work of the Congress Committee of the National Council of Nurses and the British Red Cross Society, which had drafted a Scheme for a Florence Nightingale International Foundation, was presented and was already arousing wide and sympathetic interest in many parts of the world.

Florence Nightingale Day.

The following Resolution had been unanimously adopted: "That the International Council of Nurses be invited to adopt a date as 'Florence Nightingale Day' when the Nurses of the World may express gratitude for their association with her genius."

Arrangements for I.C.N. Congress.

Active correspondence had taken place between the President who is a member of the Programme Committee, and the Officers of the International Council of Nurses in the arrangements for the Meetings of the Board of Directors and Grand Council in Paris-Brussels, July 4th to 15th, 1933.

Mrs. Bedford Fenwick will preside at the Sectional Meeting on the evening of July 11th, at the Reception of Newly Affiliated National Associations and National

Representatives.

Miss M. E. G. Milne, Matron of St. Mary's Hospital, Paddington, W., will take the Chair for the Sectional Meeting on July 11th, on "The Preliminary Course."
