THE TRAINED NURSES' ASSOCIATION OF INDIA.

The Trained Nurses' Association of India have recently held a most successful Conference at New Delhi, when 53delegates from all parts of India and a number of visitors

from the Nursing Profession were present. Her Excellency the Countess of Willingdon, wife of the Viceroy, opened the Conference.

Miss Abram, Matron of the Presidency General Hospital, Calcutta, in her presidential address said that last year had been a year of progress, and referred to the Florence Nightingale Memorial and to "Nightingale Week," which was held in July last in London. The memorial, she said, was to be a living one and not a museum. It would take the form of scholarships in which nurses from all over the world could participate. For this purpose £200,000 was required to form a permanent endowment, which would include 20 annual scholarships. The Scheme provided that every country should form a National Florence Nightingale Memorial Committee, and hoped that every member of the Trained Nurses' Association of India would co-operate in any effort that was being made, and be able to send in their quota yearly, so that nurses in all parts of India might benefit by the scholarships. The President next referred to the International Congress

of Nurses to be held in Paris-Brussels next July, and to the benefit of an insurance scheme and provident fund for nurses. She wanted such a scheme to come under their Association and be an All-India scheme for nurses.

The announcement was made that the Committee of the Association had received as gifts from different provinces and realised from a sale of work on the previous day the sum of Rs. 2,300 towards the fund for sending Indian delegates to the International Congress of Nurses, which promised to be a most representative gathering of nurses from all over the world, and at which a wide range of nursing matters were to be discussed.

THE INTERNATIONAL COUNCIL OF NURSES.

"ROYAL NURSES" TO ATTEND THE CONGRESS.

In reply to the letter from our National Council addressed to Mile. Chaptal, President, I.C.N., inviting her opinion as to whether the "Royal Nurses" who are the *motif* of the Annual Dinner of the British College of Nurses in May next, could appropriately attend the Ceremony to be held in Paris, on the evening of July 11th, at the Reception of Newly Affiliated National Associations, and if so could she name a "Royal Nurse" for France? Mlle. Chaptal writes as follows: —" At the meeting of the Programme Committee which met yesterday (November 29th) I submitted your very interesting proposal for the presentation of your beautiful 'Royal Nurses.' The audience was very appreciative and it was decided that I should ask you if the beautiful ladies could appear on the platform, on July 11th, at the end of the Meeting, as a sort of 'tableau vivant' that would be shown only when the new National Organisations have been admitted.

For France we have a beautiful example in Blanche de Castille, Queen of France and Mother of St. Louis. She was the nurse of the poor and a model of Christian virtues.

One more suggestion was brought forward ; that we ask the different countries to bring their traditional nurse's costume so that a procession of representative nurses could be shown on the platform that same evening for the greatest pleasure of the audience. The advantage of this defile would be to give time for your 'Royal Nurses' to be arranged in a tableau behind a curtain meanwhile. Each country would try to find a representative costume of old times, and in France we could, very probably, be able to show a religious robe from XIth century.'

Madam,

In reply to your letter of October 14th (MSR.CB) I am directed by the Minister of Health to say that in accordance with Section 5 of the Nurses Registration Act, 1919, he approves the proposal of the Council to reduce the fee for re-entering the Preliminary and Final Examinations held by them, at present fixed by the Regulations for the conduct of the examinations at half the examination fee, to a fee of ten shillings and sixpence for each subject in which a candidate is re-examined.
