The cheque for £250 from The League of St. Bartholomew's Hospital Nurses has been paid into the Central Fund to be administered by the Conjoint Committee. This sum concludes the £1,250 guaranteed by the National Council of Nurses of Great Britain for five complete Scholarships. # SCHOLARS RECOMMENDED.

#### FOR ENGLAND.

## Course in Public Health for Nurses.

Miss Marjorie Winifred Smith, S.R.N., age 27, entered the Nightingale Training School, St. Thomas's Hospital 1926–1930, and holds the Certificate of the School.

On completing her course Miss Smith obtained the Certificate of the Central Midwives Board, taking a year's course in the Maternity Department at St. Thomas's Hospital, and obtaining experience in Mother-craft, Venereal Diseases, Ante and Post-Natal work. Miss Smith desires to take up Public Health Work as her future career.

Miss Smith holds the Senior Cambridge Certificate and is a member of the Nightingale Fellowship.

#### FOR SCOTLAND.

Course for Nurse Administrators and Teachers in Schools of Nursing.

Miss Elizabeth Cleghorn Thomson, R.G.N., age 31-Miss Thomson was educated at St. George's High School, Edinburgh, and at St. George's Teachers' Training School. She entered the Training School for Nurses of the Royal Infirmary, Edinburgh, in 1925–1929. On completing her training and gaining the Certificate she was appointed Assistant Sister Tutor, she then took Midwifery Training, 1929–30, and was later Joint Nursing Superintendent at the Mure Memorial Hospital, Nagpur, C.P. India, 1931–1932.

Both candidates were highly recommended by the respective Matrons of their Training Schools.

DISTRIBUTION OF SCHOLARSHIPS FOR THE SESSION 1933–1934.

We learn with the greatest pleasure that it is probable that a full compliment of students will be admitted to the International Courses in London next Session, coming probably, from the following countries:

Czechoslovakia, Iceland, Finland, Greece, Sweden, Spain, Mexico, India, Italy, Norway, Greece (Greek Colony, Alexandria), England, Scotland, Australia, South Africa, Poland, Hungary, Lithuania, New Zealand, and Canada (working in India). We specially congratulate the League of Red Cross Societies, the Nurses of Great Britain and of other countries, on the success of their united work in financing the "Interim Year," 1933–34, and have no doubt whatever that when an approved international scheme is agreed the Nightingale Foundation will receive liberal and enthusiastic support throughout the World, and will exercise in the future a most beneficent influence in raising the health and consequently the happiness of the people who dwell therein.
