## GENERAL NURSING COUNCIL FOR SCOTLAND.

The General Nursing Council for Scotland was held at 18, Melville Street, Edinburgh, on Friday, May 26th, 1933. Sir John Lorne MacLeod, G.B.E., LL.D., Chairman of the Council, occupied the Chair and 14 Members of the Council were present.

The Report of the Education and Examination Committee was submitted by Col. D. J. Mackintosh, C.B., M.V.O., the Convener of the Committee, and was approved.

Authority was given for the issue of a duplicate Certificate of Registration to a Nurse whose Certificate had been lost. The name of Miss S. Macdonald, Glasgow, was removed from the Council's Panel of Examiners at her own request on leaving Scotland and applications for appointment to the

Panel from three other applicants were approved.

Details in regard to the arrangements for the Oral Examination this month were approved and the usual monthly accounts were reported as passed for payment by

the Finance Committee.

## THE GENERAL NURSING COUNCIL FOR ENGLAND AND WALES.

The one hundred and forty-sixth Meeting of the General Nursing Council for England and Wales was held at the offices of the Council, 20, Portland Place, London, W.1, on May 26th, 1933. The Chairman, Miss E. M. Musson, C.B.E., R.R.C., LL.D., presided.

## Finance.

On the recommendation of the Finance Committee, bills and claims submitted for payment were approved, and the sum of £100 for Postage Stamps, £20 for Insurance Stamps, £20 for Petty Cash, and £8,500 for Examiners' Claims and Expenses in connection with the May Examinations, allowed.

#### Registration.

Applications for Approval for Registration on May 26th, 1933, were: General Register by Reciprocity, 4; Supplementary Part of the Register for Fever Nurses, by Examination 12. ination, 12. Total 16.

It was agreed that 40 Nurses, who had hitherto failed to pay their retention fee, and now wished their names re-included in the Register, should be re-included.

### Education and Examination.

On the recommendation of the Education and Examination Committee, it was agreed that :-

Sutton and Cheam Hospital, Sutton, Surrey, be provisionally approved as a complete training school for nurses for

a period of one year.

Malmesbury and District Hospital, Wiltshire, in affiliation with the Royal United Hospital, Bath, be provisionally approved as a training school under Section 1 (1) (b) of the

Council's Scheme of Training for a period of one year.

The Orthopædic Hospital, Hartshill, Stoke-on-Trent, in combination with the London Road Hospital, Stokeon-Trent, be provisionally approved for a period of one year as a training school under Section 1 (1) (d) of the Council's Scheme of Training.

It was agreed that the Battersea General Hospital, London, be now approved as a complete training school for nurses. The Princess Louise Kensington Hospital for Children, London, be now approved as a complete training school for Sick Children's Nurses. The Cuddington Isolation Hospital, Banstead, be now approved as a complete training school for Fever Nurses. The provisional approval granted to the Frenchay Park Sanatorium and Orthopædic Hospital, Bristol, in affiliation with the Southmead Hospital, Bristol, be continued for a further year.

It was agreed that the proposed scheme of affiliation

between the County Hospital, Clayton, Bradford, and the Dewsbury and District General Infirmary, be approved.

On the recommendation of the Education and Examination Committee, the application from the authorities of St. Luke's Hospital, Huddersfield, that the combined Scheme of Training extending over a period of four years, under which the probationers of St. Luke's Hospital will spend a portion of their training in St. Luke's Hospital, Huddersfield, Royal Infirmary, Huddersfield, Mill Hill Isolation Hospital, Huddersfield, and Bradley Wood Sanatorium, be approved.

## Mental Nursing.

On the recommendation of the Mental Nursing Committee, it was agreed that the Cefn Coed Hospital, Swansea, be provisionally approved as a complete training school for Male and Female Mental Nurses, for a period of one year.
