THE DIABETIC DIET.

With Recipes for Household Use.

A very useful little book "The Diabetic Diet." the Diabetic needs to know about Diet, for easy use in all households" is published by Messrs. John Bale, Sons and Danielsson, Ltd., 83/91, Great Titchfield Street, London, W.1, price 2s. It has been compiled by a Science Graduate and a Certified Dietitian (University of London), and revised by a well-known Physician—an authority on nutrition.

"Diabetes," we are told, is a condition of disordered metabolism, the system being unable to utilise in the normal manner the food substances necessary for nutrition and muscular effort. Therefore, proper diet is the fundamental principle in the treatment, and all leading authorities agree that the best results are obtained by feeding diabetics on a balanced diet.
"Dr. R. Hutchison, in the standard English work 'Food

and Dietetics' gives the average daily requirements of the three principal food constituents for a normally active person in the following proportions: protein, 16 per cent.;

fat 1.2 per cent.; carbo-hydrate 72 per cent.

It will be noted that the outstanding feature is the preponderance of carbohydrate (sugars and starches in their various forms) and this is why the method—formerly in use, but now definitely abandoned—of excluding starch entirely from the diabetic diet is shown to have been fundamentally wrong. The process by which the three food elements are metabolized in the digestive system, each aiding in the absorption of the others, is now a well-known scientific fact, and the dietetic treatment of diabetes provides for carbohydrate or starchy foods to the maximum that can be tolerated. The carbohydrate is, in fact, the key factor in the diet—a deficiency causing acidosis or an excess giving rise to sugar."

The importance of keeping abreast with the latest scientific knowledge on the subject is thus apparent.

Provided that the physician has determined the diet of a diabetic patient on a scientific basis, which must be strictly adhered to, it is capable of "almost infinite variety and will be such that all members of the household can partake of and enjoy it." Included in the book are a number of attractive recipes which go far to establish this statement.

We commend the book to the attention of nurses, and also to diabetics upon whom devolves the application of the principles laid down by the physician.

PRACTICAL POINT.

The Administration of Insulin.

When preparing insulin for administration to a patient it is an excellent plan to keep a needle for drawing the prescribed dose of insulin into the syringe, and then to detach it, and attach the needle to be used in the actual administration,

This is desirable for two reasons. (1) The cost of hypodermic needles to a diabetic patient is quite considerable, and it is manifest that these needles will need renewing less frequently if they are not used two or three times daily to pierce the dense rubber cap, covering the mouth of the vial containing the insulin, and (2) because the injection will cause less discomfort to the patient if the fine and delicate needle has not been inevitably slightly blunted from the first, and increasingly so with each dose given, before being applied to his skin. We commend the point to nurses as a very practical one.
