THE FLORENCE NIGHTINGALE MEMORIAL COMMITTEE.

I.C.N. AND THE FOUNDATION.

Official communications have now passed between the International Council of Nurses and The League of Red Cross Societies notifying that the former has approved the Draft Scheme of the Florence Nightingale International Foundation as a basis of future organisation, which notification has been acknowledged with satisfaction.

We may hope therefore that at an early date the Provisional Committee of six representatives will meet and take counsel together as to the methods of organisation to be pursued.

In the meantime the 17 International Students entered for the 1933-1934 Courses are in residence at 15, Manchester Square, London.

As Chairman of the I.C.N. Nightingale Memorial Committee, Mrs. Bedford Fenwick has recently received letters from members, of a very hopeful nature. International co-operation is all that is required to attain success for a well-organised scheme. She is communicating with the thirty-five members who form the I.C.N. Committee, inviting expressions of opinion and suggestions from them, which will be carefully tabulated, for the consideration of the Grand Council of the Foundation, when it is formed.

THE FLORENCE NIGHTINGALE SCHOLARSHIP FUND.

Through Miss E. S. Innes, the Matron of the General Infirmary, Leeds, an additional £10 has been received in

response to the National Council of Nurses' Appeal for the Florence Nightingale International Memorial Fund from the Nursing Staff of the General Infirmary.

A most generous gift of £50 has already been subscribed by the members of the Leeds General Infirmary Nurses' League and the Nursing Staff, and the thanks of the National Council of Nurses have been conveyed to the subscribers through the Matron, Miss Innes.

Everyone interested in the Florence Nightingale Memorial Foundation will be greatly pleased to learn from the *Queen's Nurses' Magazine* what a generous response has been made to the Queen's Institute Appeal. The Magazine reports that the Associations of Queen's Nurses in England, the Irish Free State, Northern Ireland and Wales have been particularly generous. The total received to date is £430. The Magazine adds, "If another £70 could be raised we should have the great pleasure of forwarding £500 to the Central Fund. The Fund is open until the end of September."

THE FLORENCE NIGHTINGALE MEDAL.

The Florence Nightingale Medal has been awarded to Miss E. M. Macfarlane, R.R.C., Lady Superintendent of St. George's Hospital, Bombay; Miss A. M. Phillips, R.R.C., Chief Principal Matron in India, Q.A.I.M.N.S., Simla; Miss Wallis, late Lady Superintendent, Civil Hospital, Karachi; and Mrs. Charlotte M. Heilman, Assistant Director of Public Health Nursing, American Red Cross Headquarters, Washington, D.C.

The medal was established in 1912 as a Memorial to Florence Nightingale by the Ninth International Red Cross Conference meeting in Washington. It is awarded annually to six graduate nurses.
