# THE NATIONAL COUNCIL OF NURSES OF GREAT BRITAIN:

## MEETING OF THE EXECUTIVE COMMITTEE.

The half-yearly meeting of the Executive Committee of the National Council of Nurses of Great Britain was held at 39, Portland Place, London, W.1, on Wednesday, October 18th, 1933, at 4.15 p.m. The President entertained the members present to tea at 4 p.m.

The Minutes were then read by the Hon. Secretary, and confirmed and signed by the President.

#### BUSINESS ARISING.

The President reported that as a result of her correspondence with the Chairman of the Nominating Committee of the I.C.N. the omission of certain names on the election papers was brought before the Grand Council, and the Council agreed to have three other names inserted on the Ballot papers, at the Election for Hon. Officers.

The President also stated that such strong objection to Mr. James Batey's Bill (Nurses' Registration Act, 1919, Amendment Bill) had been registered by the leading Nurses' Organisations that its second reading had been successfully blocked, and the Bill had been withdrawn from the House of Commons.

Letter from Miss Norah Green, General Secretary, National Council of Women of Great Britain *re* the Annual Meeting and Conference held at Torquay from 9th to 13th

October, 1933. The President pointed out that owing to the National Council of Women holding its Annual Meeting early in October, prior to the Meeting of the Executive Committee of the National Council of Nurses of Great Britain, the National Council of Nurses was unable to express its opinion on the Resolutions submitted. She drew the attention of the Meeting to the fact that the following Resolution was proposed by Mrs. Keynes, J.P., and seconded by Miss Gwatkin, Member General Nursing Council for England and Wales.

"That this Council is of opinion that in order to increase the number of suitable candidates for the Nursing Profession it should be made possible for pupils to take part of the Preliminary Examination before leaving a secondary school, thus stimulating their interest and relieving the pressure of the first year in hospital."

Although a few professional Delegates spoke in opposition, others were unable to voice their opinions owing to lack of time, and the Resolution was adopted by a large majority of the laity present.
