on the Council. The Ministry has been informed that the large body of Municipal Nurses and District and Public Health Nurses consider that practical experts in these national branches of nursing might well be represented with benefit in the deliberations of the Council.

THE SPLIT PRELIMINARY EXAM.

The infiltration of the General Nursing Council with the "Split Preliminary" policy of The Lancet Commission, attained by the appointment, by the Ministry of Health, of the second assistant editor of that journal to a seat on the Governing Body of the Nursing Profession, has aroused a strong sense of resentment upon the part of Registered Nurses who object to press control.

The Lancet stood severely aloof during the nurses' long struggle for legal status and the organisation of nursing education by the State, and there appears no reason why it should now interfere with the rights and privileges acquired by them under the Nurses' Registration Act.

The place of the Press is at the Press Table, and not on

our Board of Control.

Miss Bushby said that the Nursing Organisations had showed great interest in the matter, and that the response to the appeal had been most gratifying, four of the large Leagues of Nurses having promised to provide a scholarship each of £250, and that £500—the amount originally to be collected—was rapidly coming in.

There was some discussion on the best method of obtaining the co-operation of the members of the Matrons' Council, and it was decided, on the motion of Mrs. Andrews, seconded by Miss Bushby, that a circular letter be sent to every member, inviting contributions.

Other methods of raising money were suggested, and a sum of over £12 was promised by the members present; so that a good start having been made, it is hoped to enlist the sympathy of all the members of the Council and to give to each individual member an opportunity of taking part in this great International effort to com-memorate the genius of Florence Nightingale.

After the termination of the Meeting, tea was served in the beautiful drawing-room of the R.B.N.A Club, and
