PROGRAMME.

CONGRESS, PARIS-BRUSSELS, July 10th to 15th, 1933.

MEMBERS OF THE CONGRESS.—Only members of affiliated organisations of the I.C.N. can register as Members of the Congress.

THE METHOD OF REGISTRATION FOR THE CONGRESS is as follows :--- Those desiring to attend the Congress coming from the 23 countries in which the I.C.N. has affiliated organisations must obtain an authorisation from the Headquarters of their National Nurses' Association. The 23 countries are as follows :-Belgium, Brazil, Bulgaria, Canada, China, Cuba, Denmark, Finland, France, Germany, Great Britain, Greece, Holland, India, Irish Free State, New Zealand, Norway, Philippine Islands, Poland, South Africa, Sweden, U.S.A., Yugoslavia.

THE REGISTRATION FEE FOR MEMBERS to the Congress is 50 French francs, plus 25 French francs if the report of the Congress proceedings is desired. The registration fee and the authorisation mentioned above should be sent as soon as possible to the Congress Arrangement Committee, 6, rue François Ier, Paris, giving the name, position and address of the sender : the receipt sent in return should be presented when registering in Paris or Brussels.*

THE OFFICIAL LANGUAGES OF THE CONGRESS are : English, French and German, The programme and the main papers of the Congress will be printed in these languages. Interpretation will be arranged for at meetings involving discussion.

REGULATIONS FOR SECTION MEETINGS .- Main papers read at a Section Meeting shall not exceed 15 minutes. The Speaker opening the discussion shall be allowed 10 minutes; speeches from the floor shall not exceed five minutes each, apart from their interpretation.
