### THE BRITISH COLLEGE OF NURSES.

#### REPORT OF THE COUNCIL.

The seventy-fourth Meeting of the Council of the British College of Nurses was held at 39, Portland Place, London,

W.1, on Saturday, February 25th, 1933.

The President, Mrs. Bedford Fenwick, was in the Chair, and there were present:—Miss A. M. Bushby, Vice-President, Miss E. Brodie, Miss M. S. Cochrane, R.R.C., Miss N. Farrant, Miss G. Le Geyt, Miss I. Macdonald, Fellows; Miss H. G. Ballard and Miss E. J. Haswell, Members.

Prayers having been read by the Secretary, the Minutes

of the last Meeting were confirmed.

The President reported a letter of regret for absence from Miss Margaret Breay, who had removed from the Nursing Home to her flat at Brighton, and hoped to attend the Council at an early date.

Business Arising Out of the Minutes.

1. The following communication received from Sir Montagu Cox, Clerk of the London County Council, in reply to a letter sent from the Council of the British College of Nurses, objecting to employment of unregistered Nurses as Sisters, was read:-

London County Council, The County Hall, Westminster Bridge, S.E.1. 2nd February, 1933.

MADAM,

With reference to your letter of the 3rd ultimo, I am directed to state that the observations of the Council of the British College of Nurses on the decisions of the Council regarding (i) the extension from three to four years of the period of training in general nursing for probationer nurses at hospitals under the management of the Central Public Health Committee, and (ii) the qualifications of departmental sisters (massage, X-ray and electrical departments) have been carefully considered. In reply to the various points raised in your letter regarding the first matter, I am directed to state as follows:—

(a) Under the new scheme of training the large majority of the probationer nurses will sit for the examination of the General Nursing Council probably during the early portion of their fourth year of training. The actual time will obviously depend both upon the date on which they joined the service and the date of the General Nursing Council's examinations, but all probationer nurses undergoing general nursing training will complete the four-years' course irrespective of the date on which they take the examination of the General Nursing Council.

(b) No special branches of training will be covered

during the extended year of training.

(c) Probationer nurses now undergoing training will continue their training under the terms of the scheme at present in operation, i.e., for a three-years' course. It is proposed, however, to recommend the Council to allow probationer nurses recruited before 1st April, 1933, the opportunity of taking, if they so desire, a four-years', instead

of a three-years, course of training.

With regard to the question of the qualifications of departmental sisters (massage, X-ray and electrical departments)

I am to state that after careful review the Sub-Committee concerned are not prepared to advise the reversal of the decision of the Council in the matter.
