ARRANGEMENTS FOR THE CONGRESS OF THE INTERNATIONAL COUNCIL OF NURSES, PARIS-BRUSSELS, JULY 10th to 15th, 1933.

Historic Royal Nurses.

The President reported that the suggestion from the Grand Council of the National Council of Nurses that the "Historic Royal Nurses" should be represented at the International Congress in Paris had been received with warm approval by Mlle. Chaptal and the Arrangements Committee. It was also proposed that a Procession should be composed of a celebrated nurse from each country. She had communicated with Miss Lloyd-Still on this matter.

The President stated that the first proposal was to have a "History" Dinner by the British College of Nurses on May 4th, when the eight Historic Royal Nurses would be represented. They would include Queens from the fourth to the fourteenth century in the following order:—

The Empress Helena; Margaret of Scotland; Matilda the Good, wife of Henry I; St. Elizabeth of Hungary; Matilda, wife of Stephen; Marguerite de Provence; Queen Eleanor, wife of Edward I; and Queen Philippa, of Hainault, wife of Edward III.

As the Tableau of these Royal Nurses at the International

Congress of Nurses in Paris represented wider interests than the British College of Nurses only, it was agreed to ask the League of St. Bartholomew's Hospital Nurses, the Association of Hospital Matrons and the College of Nursing to nominate a member to represent three of the Royal Nurses. The two former had consented, but the College of Nursing was not able to comply with the request.

The Registration of Congress Fee.

The President reported that Mlle. Chaptal had communicated with Miss Musson and herself, recommending that the Congress Fee of 50 francs should be paid in advance by those members attending the Congress, as this would facilitate travel arrangements abroad and prevent disorganisation when registering in Paris. The proposal of each individual member forwarding their fee to Paris appeared one of great difficulty, so she had interviewed a representative of Thos. Cook & Son, and suggested that members should pay their registration fee of 50 francs when paying for their inclusive travel tickets, for which they would get a separate receipt, and that the firm should transmit the money to Headquarters in Paris. This the firm had agreed to do, if approved by the Committee.

It was agreed that such an arrangement would save Members attending the Congress endless trouble.

Miss Sparshott proposed, and Miss Macdonald seconded, and it was agreed that this plan should be adopted.

Identification Certificate.

The form of the Identification Certificate for Members attending the Congress, as previously used, to be signed by the President, was approved.

Each Member will be required to present the Certificate recommending her inscription as a member of the Congress to Thos. Cook & Son before she can avail herself of the special terms for reduced travel and hotel arrangements in Paris and Brussels, which are of a generous nature.

Those eligible for the co-operative privileges are the members of every Affiliated Association of the National Council of Nurses of Great Britain.

Non-Members and Visitors.

Unprofessional visitors are not eligible to register as members of the Congress from countries where an affiliated National organisation exists.

The question of nurse non-members was considered at length, and it was ultimately agreed that a limited number of nurses who might justifiably partake of the privileges of the Congress might receive identification papers as visitors and not as members, upon the payment of a small fee to the National Council of Nurses. As the member organisations had financed their National and International Councils to the extent of several thousand pounds during the quadrennial period. It was agreed that Nurse Visitors should pay half a guinea.

Cook's Revised Arrangements.

Revised arrangements as to travel, etc., agreed to by Thos. Cook, Ltd., were approved. There would be two trains from London to Paris on July 8th, one at 9 a.m. and one at 4 p.m. This will add greatly to the comfort of travellers. (See Itinerary on page 77.)

I.C.N. Business.

It was hoped that business to be brought before the Board of Directors of the Grand Council and Congress of the International Council of Nurses would be ready for consideration at the April Meeting of the Executive Committee.

The Meeting then terminated.
