THE HISTORY DINNER.

The arrangements for holding the History Dinner by the British College of Nurses at Grosvenor House, Park Lane, on May 4th, are now almost complete.

The Dinner will be held in the Ball Room which lends itself admirably to such a function—and already nearly all the 170 tickets available are sold, the members of the College and their friends, no doubt having in memory former occasions on which they have met around the festive board, and enjoyed fine speeches, an excellent menu, and delightful company.

This year the Council, many members of which are deeply interested in Nursing History, and its association for many centuries with higher civilisation, arranged to recall to the guests the beneficent influence of Historic Royal Nurses, who in centuries past played so noble a part in the world's progress.

The eight Royal Nurses, who will be seated on golden chairs in the centre of the room opposite the Chair, which is to be taken by Mrs. Bedford Fenwick, the President, will wear fine period costumes (somewhat etherealised), their crowns, jewels, and emblems. They will enter the room in procession, after the guests are seated, and should present a very imposing octave.

1. The Empress Helena (Saint), Mother of Constantine the Great, Miss A. M. Bushby, F.B.C.N. Robe, golden brocade and purple velvet mantle, white veil, jewelled Cross.

- 2. Margaret of Scotland (an Anglo-Saxon Princess), wife of Malcolm Canmore, King of Scotland. Miss Shelagh Nunn Patrick. Kirtle pale green, and white velvet mantle, white veil and long golden plaits—so renowned in history.
- 3. Matilda of Scotland (surnamed The Good), wife of Henry I, who gave lands to Rahere, on which to build St. Bartholomew's Hospital. Miss K. M. Latham, R.R.C., M.B.C.N., nominated by the League of St. Bartholomew's Hospital Nurses. Robe vieux rose and gold brocade—and rose velvet mantle.
- 4. Matilda of Boulogne, wife of Stephen. Miss E. J. Haswell, M.B.C.N. Kirtle, gold and mauve silk and mauve velvet mantle.
- 5. Marguerite de Provence, wife of Saint Louis, King of France. Miss Beatrice Treasure, F.B.C.N. Robe, azure blue and silver brocade, embroidered in silver, Royal blue mantle.
- 5. Eleanor of Castile, wife of Edward I., Miss L. G. Duff Grant, nominated by the Association of Hospital Matrons. Kirtle, orange and gold brocade and flame velvet mantle.
- 6. Saint Elizabeth of Hungary (The Holy Elizabeth), wife of Louis Langraf of Thuringia. Miss Rosemary Eley. Robe, peach blue and gold brocade and peach pink mantle.
- 8. Philippa of Hainault, wife of Edward III of England, and mother of the Black Prince. Mrs. Christian Bedford Fenwick. Dress, cream and gold brocade, and crimson velvet coat, trimmed ermine, and Order of the Garter (dark blue).

Guests of Honour have been invited whose names are well known as historians, and others associated with the three splendid Royal Foundations of the City of London to grace the high table. As already announced, after the Loyal Toasts, Miss Isabel Macdonald will deliver the Oration on the beneficent and saintly lives of the eight Historic Royal Nurses.

Success to the Three Royal Foundations: St. Bartholomew's Hospital, St. Thomas's Hospital and the Bethlem Royal Hospital, will follow, on which the speakers will be respectively: Sir D'Arcy Power, K.B.E., M.A., F.R.C.S., Dr. F. G. Parsons, D.Sc. (Lond.), F.R.C.S., F.S.A., author of "The History of St. Thomas's Hospital" from the earliest times until A.D. 1600; and Dr. J. G. Porter Phillips, M.D., F.R.C.P., Physician-Superintendent, Bethlem Royal Hospital.

Success to the History Section of the British College of Nurses will be proposed by Miss G. Le Geyt.

Miss M. S. Cochrane, R.R.C., will Welcome the Guests, and Sir George Turner, K.B.E., C.B.E., F.R.C.S., Late Surgeon Rear-Admiral, Royal Navy, Lt.-Col. R.A.M.C., and author of "Mary Stuart: Forgotten Forgeries," will respond for the guests.
