associations concerned a scheme was adopted whereby in return for services rendered by the district nursing associations in dealing with patients for whom care in the Council's hospitals is not essential, the Council substantially increased its grant, that for the half-year to 31st March, 1933, being at the rate of £4,000 a year. The offer of the Central Council for District Nursing in London to distribute the Council's grant to the several district nursing associations was accepted."

### Settlement of Uniform Scales and Conditions. No dearth of Applicants for Training.

It is interesting to note the Committee's report on the effect of uniform conditions on applications for vacancies as

probationers. "The shortage of candidates for the nursing profession had in the past been felt in the public hospitals in London as well as elsewhere. The settlement of uniform conditions promptly had its effect in an increasing number of applications for entry as probationers to the Council's service. For 2,632 positions of probationer nurse filled in the year ended 31st March, 1933, there were 9,671 applications.

"During 1930 and 1931 the engagement of an additional 650 nurses was authorised to bring up to a better standard the nursing of the general hospitals and allocated institutions and also to enable the services of temporary nurses engaged continuously in the general hospitals through the agency of nurses' institutes to be dispensed with, at a saving in cost. For necessary supervision the staff of sisters has been increased by about 80. The total increase in nursing staff is about 930."

It thus appears that there is no dearth of candidates for training when the conditions are acceptable.

# BOARD OF TRADE ANNOUNCEMENT.

### Insulin and its Salts Chargeable with Duty under the Safeguarding of Industries Act.

The application by the Association of British Chemical Manufacturers, on behalf of certain firms, to include foreign insulin in the list of dutiable articles under the Safeguarding of Industries Act, was recently considered by a Board of Trade Tribunal presided over by Mr. Henn Collins, K.C.

A general ad valorem duty of 10 per cent. has been hitherto collected on all imported insulin used by diabetic sufferers.

It was claimed by the British Manufacturers that insulin is a fine chemical produced by a highly skilled chemical process.

The application was opposed by Messrs. C. L. Bencard, Ltd., importers of Danish insulin.

The following announcement was subsequently issued by the Board of Trade:—"The Tribunal constituted under Section 1 (5) of the Safeguarding of Industries Act, 1921, as amended by the Finance Act, 1926, has issued its decision on the complaint that 'insulin and its salts' has been improperly excluded from the list H iii, issued by the Board of Trade, of articles chargeable with duty under the Safeguarding of Industries Act.

A majority of the members of the Tribunal have decided that 'insulin and its salts 'should be added to the list, and the list is being amended accordingly with effect as from

14th December, 1933."

The result of this decision is that insulin becomes subject to the key industry duty of 33\frac{1}{3} per cent. ad valorem.

In the House of Commons Dr. Burgin, Parliamentary Secretary to the Board of Trade stated in reply to questions that "an undertaking had been given on behalf of British makers that their price would not be raised as the result of the new duty. (Cheers.) The Minister of Health had the price of insulin very much in mind and proposed to watch it closely."
