THE BRITISH COLLEGE OF NURSES.

REPORT OF THE COUNCIL MEETING.

The eighty-seventh Meeting of the Council of the British College of Nurses was held on Saturday, April 21st, 1934 at 39, Portland Place, London, W.1, at 2.15 p.m. The Vice-President, Miss A. M. Bushby, was in the

Chair, and there were present :--Miss M. G. Allbutt, Miss M. S. Cochrane, R.R.C., Miss J. C. Cowie, Miss G. Le Geyt, Miss I. Macdonald, Fellows, Miss H. G. Ballard and Miss E. J. Haswell, Members.

Prayers having been read by the Secretary, the Minutes

of the last Meeting were confirmed. On rising, Miss Bushby placed before the Council a letter she had received from the President, Mrs. Bedford Fenwick, in which she expressed her regret that she could not be with them, and sending good wishes for a successful meeting.

It was unanimously agreed that a letter be sent to the President, expressing the unanimous hope of all present that she would benefit'by rest and sea air.

BUSINESS ARISING OUT OF THE MINUTES.

THE SPLIT PRELIMINARY EXAMINATION IN SCOTLAND.

The correspondence between the College and Mr. W. S. Farmer, Registrar, General Nursing Council for Scotland, was presented as published in the April issue (page 104) of THE BRITISH JOURNAL OF NURSING.

The Council of the College was awaiting a reply to its communication to the General Nursing Council for Scotland dated March 27th.

This letter has been acknowledged by the Registrar of the General Nursing Council for Scotland, who states it will be placed before the next Meeting of his Council.

THE CONTRACEPTIVES BILL.

In reply to the Resolution sent from the Council of the British College of Nurses re the Contraceptives Bill, "To regulate the sale and advertisement of contraceptives" introduced into the House of Lords by Lord Dawson of Penn, that "under Clause 1, Sub-section (i) the words registered nurse or certified midwife' should be omitted, as their inclusion provides for the treatment of patients by registered nurses and midwives without medical direction.

The following letters have been received :-

(a) Lord Dawson—" begs to acknowledge with thanks your communication."
(b) The Right Rev. The Lord Bishop of London, P.C.,

K.C.V.O.:-"The Bill has now passed the third reading in the House of Lords, and therefore no amendments can now be made in the House of Lords.

"Any Amendments which you think necessary can be forwarded to whoever is in charge of it in the House of Commons, but I am afraid it will not come before the House of Commons at present."

(c) The Secretary of Lt.-Cdr. The Rt. Hon. Sir Hilton

letter of March 19th and for sending him a copy of the Resolution with regard to the Contraceptives Bill adopted by your Council on March 17th.'

(d) Sir Francis Fremantle, O.B.E., M.P., Chairman,
 Parliamentary Medical Committee, House of Commons:-- "Thank you for your letter of the 21st inst., I quite

agree; it seems a most astonishing proposal. But there does not seem to be the remotest chance of the Bill being introduced into this House this Session; and before another Session the British College of Nurses might well ask Lord Dawson if he would agree to the words in question being omitted."

(e) Dr. Somerville Hastings, M.S., F.R.C.S., Chairman, The Hospitals and Medical Services Committee, London

regard to Lord Dawson of Penn's Bill 'To regulate the sale and advertisement of contraceptives,' and note the views of the College which you have been kind enough to send to me. I am afraid, however, that the matter to which you refer hardly comes within the sphere of the County Council as no registered nurses or midwives employed by them would be allowed to engage in any business such as that of the sale of contraceptives.

I have no doubt that the point which you make will be fully considered by the proper authority, which is Parliament."

The following reply was sent to Dr. Somerville Hastings:-"I beg to thank you for your kind letter of March 23rd. I note your statement concerning the matter to which I referred, that it ' hardly comes within the sphere of the County Council, as no registered nurses or midwives employed by them would be allowed to engage in any business such as that of the sale of contraceptives."

"With all due deference to this expression of opinion, should registered nurses and certified midwives be empowered by Act of Parliament to sell contraceptives, it would be extremely difficult for any Public Body such as the London County Council, employing nurses, to over-ride the provisions of Parliament. "You will realise, therefore, that my Council is of

opinion that prevention is better than cure, and we hope that should this Bill be introduced into the House of Commons, the influential Committee of which you are Chair, will help to prevent a most dangerous proposal in reference to the professional relations of medicine and nursing, from becoming law,"
