The Sub-Committee agreed to allot the sum of £1,000 for four Scholarships, one of which should be awarded to England and one to Scotland, and paid that sum in three cheques on behalf of the National Florence Nightingale Memorial Committee of Great Britain to the Florence Nightingale International Foundation; £500 was paid on March 13th, 1933, £250 on May 15th, 1933, subscribed by the London Hospital League of Nurses, and £250 on May 29th 1933, subscribed by the League of St. Bartholomew's Hospital Nurses.

This £1,000 financed four complete Scholarships of £250 each, and have been awarded to:—

- Miss Marjorie Winifred Smith, England.
 - Miss Marija Lela Vincek, Yugoslavia.
 - Miss Elizabeth C. Thompson, Scotland.
 - Miss Edvarda Hole, Norway (half Scholarship).
 - Miss Fiorangela Codacci-Pisanelli, Italy (half Scholarship),
- who are all now resident at 15, Manchester Square, London, and have begun their studies at Bedford College for Women.

In addition £500 has been placed on deposit, leaving £104 19s. 2d. in No. 2 Account at the Midland Bank, Oxford Street, W.1.

In addition to the large sum subscribed direct to the National Council's Appeal, which appears in the Audited Accounts, £250 has been subscribed by the Nightingale Fellowship, £250 by Guy's Hospital Nurses' League, Dame Sarah Swift received £250 in response to an appeal to nurses in the press, and the Queen's Nurses through the Queen's Institute Appeal notify the sum of £470 received to date, which has been paid into the account of the National Florence Nightingale Committee of Great Britain. Thus the Nurses in Great Britain have contributed a sum of £2,824 19s. 2d. in the past year, £1,750 of which has been so far expended on Scholarships for the 1933/34 Courses.

Thus eighteen international students have been financed through the League of Red Cross Societies, the National Council of Nurses of Great Britain and by nurses in the United Kingdom.

At the last Meeting of the Sub-Committee held on November 3rd it was agreed to recommend that the balance in hand should be retained in the Bank towards the Endowment Fund of the Florence Nightingale International Foundation, an appeal for which it was hoped would be made at an early date.

Miss Allbutt proposed and Miss D. Finch seconded that the Report be received. The President commenting on the magnificent response to the Appeal, congratulated all those who had responded to it, and thus taken the initiative of the financial support by nurses of the proposed Florence Nightingale Memorial Foundation, an example which she felt sure their colleagues associated in the International Council of Nurses would emulate now that its Grand Council had approved the Draft Scheme as a basis of organisation, and had elected five Delegates as its representatives into the Governing Body of the Foundation when officially organised, which it was hoped would be possible in July 1934. It was therefore probable that interim arrangements in connection with the organisation of scholarships would be necessary for another year 1934-1935.

Since the accounts of the Appeal were audited on September 30th, the following generous Donations had been received: Westminster Hospital Nurses' League, £50, Bradford Royal Infirmary Nurses' League, £15 (by a 1s. per capita collection), Miss J. Melita Jones, New Zealand, £1. Making a grand total received to date of £1,605 19s. 2d. of which £605 19s. 2d. was in their Bank.

LETTER CIRCULATED TO THE PRESIDENTS OF NATIONAL NURSES' ORGANISATIONS OF THE I.C.N.

The President then read the following letter which she, as Chairman of the Florence Nightingale Memorial Committee I.C.N., had, together with the President I.C.N. Miss A. Lloyd-Still, addressed to the Presidents of all National Nurses' Organisations grouped in the I.C.N.

THE FLORENCE NIGHTINGALE INTERNATIONAL FOUNDATION.

To the President The National Council of Nurses of Great Britain.

DEAR MADAM,—You will no doubt have noted with interest that the proposal of the International Council of Nurses for the creation of a Florence Nightingale International Foundation is now approaching realization. We may perhaps recall that the scheme was endorsed by the Board of Governors of the League of Red Cross Societies in October, 1932, and was formally adopted by the International Council of Nurses in July, 1933.
