the Examinations in October were approved and the names of three further applicants were placed on the Council's Panel of Examiners.

The names of the Nurses who had passed the Council's Examinations in May and had attained the age of 21 were ordered to be placed on the Register.

NURSING IN THE HOUSE OF COMMONS.

APPOINTMENT OF DEPARTMENTAL COMMITTEE TO INQUIRE INTO THE TRAINING AND SYSTEM OF REGISTRATION OF NURSES IN SCOTLAND.

In the House of Commons on June 26th Mrs. H. B. Shaw, M.B.E. (Unionist, Bothwell), asked the Secretary of State for Scotland (Sir Godfrey Collins, K.B.E., C.M.G.) whether in view of the need for improvement in the system of training and registration of nurses in Scotland, he proposes to institute an enquiry into the subject.

Mr. A. N. Skelton (Unionist), Parliamentary Under-Secretary for Scotland, replied (as printed in the Official Report): "Yes, Sir, my right hon. friend has appointed a Departmental Committee on this subject. With my hon. Friend's permission I will print the terms of reference in the Official Report. The members of the committee are as follow:

Mr. Buchanan: While appreciating the fact that this is a large Committee, will the hon. Gentleman not consider putting on it some of the ordinary everyday working nurses rather than those who are heads of institutions?

Mr. Skelton: I think their case is rather a matter for evidence

Mr. Maclean: Would not the same consideration apply to the large number of matrons of hospitals?

Following are the terms of reference of the Committee:

"To inquire into the training and system of registration of nurses in Scotland and to recommend what Amendments, if any, should be made in the Nurses Registration (Scotland) Act, 1919, or the rules made thereunder, and what other steps, if any, should be taken to improve the existing system of training and registration."

The Glasgow Herald, commenting on the appointment of the Committee, says that it "provides an excellent opportunity for constructive critics of existing conditions to come forward with testimony. . . . The first good result of the investigation will be the publicity given to actual conditions in an arduous calling which ought to clear up current misconceptions."

We are not surprised that the Secretary of State for Scotland has been petitioned to appoint this Committee. In our opinion the General Nursing Council for Scotland in adopting a rule in which it takes power to "approve" educational institutions, other than nurse training schools, for the purposes of training possible entrants to the nursing profession exceeds the powers conferred upon it by the Nurses Registration (Scotland) Act. In which case any expenses incurred by it in this connection would be ultra vives, therefore the Council no doubt will welcome an opportunity to propose amendments to the Act and the Rules made thereunder, in order to regularise any action it may have already taken.
