REPORT OF THE COUNCIL MEETING.

The ninetieth Meeting of the Council of the British College of Nurses was held on Saturday, July 21st, at 39,

Portland Place, London, W.1, at 2.15 p.m.

The President, Mrs. Bedford Fenwick, was in the chair, and there were present: Miss M. Breay, Vice-President, Miss M. G. Allbutt, Miss A. M. Bushby, Miss F. M. Campbell, Fellows. Letters of regret were notified from several members of the Council on annual holiday.

CORRESPONDENCE.

Letter from Miss S. A. Villiers consenting to stand for re-election on the Executive Committee of the National

Council of Women.

Letter from the Registrar, General Nursing Council for England and Wales, stating: "I have pleasure in inform-ing you that at the Meeting of the Finance Committee on Thursday last it was decided that a copy of the Register of Nurses should be presented to the British College of Nurses annually free of charge. I am therefore sending you under separate cover a copy of the Register for the year 1934." It was unanimously agreed that a letter be sent to the Registrar of the General Nursing Council for England and Wales, expressing thanks and appreciation for the very useful gift of a copy of the Nurses' Register, 1934, and for its decision that a copy be presented annually free of charge.

Re Appointment of Departmental Committee to enquire into the training and system of nurses' registration in Scotland.

The President drew the attention of the Council to the formation of the above Committee, particulars of which were published in the July issue of The British Journal of Nursing.

DEPARTMENTAL COMMITTEE ON TRAINING OF NURSES. DEAR MADAM,

I am in receipt of your memorandum of 14th inst. and reply

to your questions as follows :-

(1) The regular sessions of the Committee will be held in

Edinburgh.

(2) The dates on which sessions will be held have not yet been fixed, but it is proposed that the next meeting should take place about the middle of October, and sessions will probably be held either weekly or fortnightly after that on dates to suit the convenience of the members.

(3) Meetings will not be open to representatives of Nurses' Organisations apart from witnesses of such bodies attending on any particular day. The Press also will not be present but notices will be issued to the Press from time to time.

(4) An official report containing the recommendations of the Committee will be published at the completion of the enquiry, but it is not proposed to publish the verbatim evidence of

I beg to acknowledge your letter of the 19th inst., which was

placed before the Council of the British College of Nurses at its Meeting on Saturday, July 21st, and my Council much regrets to find that the meetings of the Sessions of the Departmental Committee on Training of Nurses will not be open to the public or to the Press, and that the evidence will not be published, so that the Report issued will not possess the value of reasoned

My Council is of opinion that all Departmental Committees, which are financed by the State, should be open to the public.
