likely that this will proceed any further this Session as the House is fully occupied. It would, therefore, mean that if a Bill comes before Parliament, it must be a new one. Should a new Bill be drafted the Institute will give it careful consideration and will note the point raised in your letter. Yours truly, (Signed) MERCY WILMSHURST,

RULES RE LOSS OF BADGES.

Letter from Miss Woodall, enclosing two letters from the General Nursing Council for England and Wales, in which it refuses to issue duplicate badges to State Registered Nurses, and asking if the Council of the British College of Nurses approve of the Resolution of 23rd October, 1931, also when a new rule or alteration is made, is notice given in any way to State Registered Nurses? Miss Woodall has lost three badges.

It was agreed that Miss Woodall be informed that the General Nursing Council is justified in its regulations on this subject. As a result of the losses, unprofessional persons may be wearing badges issued to her. Also that new rules and alterations are usually published in the Nursing Press.

A letter from a Member saying she sent her arrears (four years), and hoping she may still be a Member of the College. This was agreed.

Letter from Miss Hersée, sending an interesting account of conditions of nursing in France, and asking if there is a possibility of a trained Medical Swedish Masseuse obtaining a post, as Masseuse, in any Hospital in England.

Replied that it would not be advisable for foreign Massense to come to England, as the profession is already overstocked.

Letters from Miss Dinnie, asking if a College representative could be sent down to her residence to select the books she would like the College to have. It was agreed to send a letter of warm thanks to Miss Dinnie for her very generous gift of books selected.

A number of private communications were dealt with. It was with regret that the Council realise that so many Nurses outside institutions are in straitened circumstances.

ELECTION OF FELLOWS AND MEMBERS.

The applications for membership were approved, and all the candidates elected. No resignations were received.

FINANCIAL STATEMENT.

The President reported a satisfactory Financial Statement, £59 17s. had been received in annual subscriptions since the last Meeting of the Council.
