The Secretary, Miss Olive Baggallay, having read the notice convening the meeting the Roll of Delegates was read, each responding to his or her name, in person or by proxy.

Mrs. Bedford Fenwick here raised the question of proxies and asked whether this meant that one member of the Council might hold any number of proxies and record votes for the delegates represented without their listening to the debates, and hearing the arguments for and against the question discussed.

It was agreed that the question of proxies should be discussed when the Bye-laws were under consideration.

The Minutes which had been circulated after the last meeting were then taken as read and confirmed.

The Report of the Committee of Management on the Foundation during the year July 1934-July 1935 was then presented and received together with the Account of Receipts and Payments for the ten months ending May 31st. 1935.

On the proposition of Miss Musson appointments made

since the last meeting of the Committee were ratified. Miss Jean Gunn (Canada) asked for the clarification of the situation in relation of the composition of the National Committees. She pointed out that the Canadian Nurses' Association had worked actively for the Foundation and obtained financial support for it while for some time the Canadian Red Cross, which had many other financial obligations on hand, did not feel able, while expressing good will, to undertake more. Recently it had associated itself with the C.N.A. and formed a National Committee, but had this not been done would the Canadian Nurses' Association have had no status in the Foundation, and no right to representation on its Grand Council?

It was pointed out by Mrs. Bedford Fenwick that Latvia, which was represented, had no National Nurses Association associated with the International Council of Nurses and the Irish Free State had no Red Cross Society and it was agreed that the question needed further consideration.

Sir Arthur Stanley then reported several gifts to the Foundation and it was agreed to send a hearty vote of thanks to the donors.

He then presented the Treasurer's Report, pointing out that the Financial Statement for 1934-1935 only covered a period of ten months, and therefore had not the value of audited accounts, as the year would not be complete until July. He gave a lucid explanation of the Balance Sheet
