The Chairman reported that the building of the new premises of the General Nursing Council would be begun on 28th inst., by Messrs. Ashby & Horner Ltd., of 8, Aldgate,

London, E.C.

It was reported that Helen Mason was summoned to appear at the Police Court at East Grinstead, and was fined £5, or, in default, 14 days' imprisonment for falsely representing herself to be a State Registered Nurse.

Finance.
