

present serving a term of six months' imprisonment at H.M. Prison at Holloway, in the second division, and who, by permission of the Home Office, was permitted to attend the meeting of the Council, under custody.

Miss Quinn, persuaded by her Solicitor, pleaded guilty at Petersfield to stealing articles belonging to her employer, to the value of £57 10s.; to the General Nursing Council she protested her innocence, and stated that she was suffering for the sin of another.

The Council considered this case *in camera*, and passed the following Resolution:

#### Resolution.

"That Miss Edith Emily Quinn, S.R.N. 41896, having been proved to have been convicted of the misdemeanour alleged against her in the Notice of Inquiry, the Registrar be directed to remove from the Register of Nurses the name of Miss Edith Emily Quinn, S.R.N. 41896."

## GENERAL NURSING COUNCIL FOR SCOTLAND.

Sir John Lorne MacLeod, G.B.E., LL.D., Chairman of General Nursing Council for Scotland, occupied the Chair at the Meeting of the Council held at 18, Melville Street, Edinburgh, on Friday, October 25th.

The Chairman made reference to the death of Miss M. L. Cameron, who was, until recently, a Member of the Council. It was unanimously resolved to record in the Council's Minutes an expression of regret at Miss Cameron's death. The Registrar was instructed to express to her relatives the Council's sympathy on their loss.

The Report of the Education and Examination Committee was submitted by Col. Mackintosh, the Convener of the Committee, and was unanimously approved.

In accordance with the recommendation of the Committee, it was resolved that overalls be obtained for the use of candidates at the Examination Centres.

The names of Dr. Morton A. Foulis, Glasgow, and Dr. John M. Melvin, Glasgow, were placed on the Council's Panel of Examiners in Anatomy and Physiology and Surgical Nursing respectively.

The Council resolved to adjust an agreement for reciprocal registration with the Manitoba Association of Registered Nurses on the lines of the agreement recently come to between that Association and the General Nursing Council for England and Wales.

The names of various Nurses who had already passed the Council's Examinations and had now attained the age of 21 were placed on the Register.

## THE INTERNATIONAL COUNCIL OF NURSES.

Miss Anna Schwarzenberg, the Executive Secretary of the I.C.N., informs us that there are four, not six, permanent members of the secretariat, at Headquarters, one of whom is English and one Austrian, both trained nurses and secretaries, and the third who is French is an expert stenographer, all under the direction of the Executive Secretary. Two additional clerical workers who helped with the Minutes, were added to the staff for one week only during the Meetings of the Board of Directors. With thirty-nine countries in affiliation with Headquarters, and a dozen languages to be understood, it is amazing how strenuous and fascinating the work in an international office can be.

The Jury of the Brussels Exhibition has awarded the diploma of Grand Prix to the Belgian Red Cross, not only for its attractive stand at the Exhibition, but also as a mark of recognition of the valuable services rendered by the Society in taking charge of the first-aid arrangements.
